

Dwight Sales Tax Referendum Fails

by Madelyn Fogarty

A referendum aimed at infrastructure improvements failed when voters from the Village of Dwight cast their ballots in the March 18 Primary Election.

With overwhelming opposition, Dwight residents turned down the referendum intended to add revenue for infrastructure improvements initially focusing on street upgrades and repairs. Election results show 563 votes were cast opposing the referendum while just 279 voters were in favor.

"I am extremely disappointed that the referendum didn't pass," Mayor Jared Anderson told The Paper. "It was an opportunity to gain additional revenue from

people just passing through the village with an estimated 50 percent of sales tax revenue through transients. Now, we will have to, unfortunately, depend entirely on the Dwight community."

The referendum asked for a ½ cent sales tax increase on certain sales, however items such as groceries, prescriptions, over the counter medicines, vehicles, service operations such as barber and beauty shops, video rental, attorneys, accountants, were excluded items and are not charged sales tax in Illinois. It was anticipated \$300,000 could have been generated annually by this increase in Dwight's sales tax.

"Passage of the sales tax

referendum and the additional funds it would bring into the Village would be a start to help in getting the Village streets back in stated Dwight shape," Village Administrator Kevin McNamara prior to the elec-

Village officials will be looking at other means to increase revenue.

"Our next move will be to raise property taxes," said Anderson. "We have not raised property taxes in the village in five years, but that will be our next option."

Only Village of Dwight residents were able to vote on the referendum. Voter turnout in Livingston County for the 2014 primary was 36.67 percent.







Tips from a Realtor: **How to Get Your Home Sold**

If there are any pets in your home, try to bring them with you if at all possible when your house is being shown. "Always make sure you let your agent know, no matter how small the pet. Beyond the club level, 4-H members can take part in workships related to project areas, participate in leadership conference, or attend 4-H Camp.

DTHS Considers Stadium Lighting Project March Board Actions

madelynfogarty@yahoo.com Plans for another project are taking shape at Dwight Township High School as members of the District #230 Board of Education showed support for a proposed stadium lighting proj-

The current lighting system at Dwight's Oughton Athletic Field was installed in 1977 at a cost of \$18,980. At that time, fixtures were installed on existing wood poles using an existing wiring system maintained at 20 foot candles. Currently, the outdated system is experiencing some major electrical problems with electrical issues somewhere underground - the lights presently function at a 15 candle reading. A foot candle equals the intensity of light in one square foot. A typical system today operates at a 40 foot candle reading. Aside from the current malfunctioning system, other reasons for replacement of the system are improved energy efficiency, improved lighting, visibility, and safety.

On hand at the March 19 board session to provide information and answer questions was David Miller of Iowa based Musco Sports Lighting. Musco, designer and manufacturer, partners with a local electrician on the project.

The proposed design includes four metal poles at

approximately 70 feet high with the electrical system completely redone and providing 40 to 50 foot candle light. The system would include safety lights behind each set of bleachers and have a keyed on/off switch.

In addition to new stadium lighting, plans to replace the field's scoreboard and goal posts are also being considered. NEVCO provided the best cost scoreboard options with discounts offered to include replacing scoreboards at the baseball and softball fields. The old style "H" goal posts would be replaced with a new gooseneck style with 20 foot uprights.

Cost estimates for the stadium lighting and electrical upgrades are \$175,000 scoreboards \$200,000; \$60,000; Goal posts \$6,000 for an overall estimated total \$266,000. Funding sources would include \$50,000 received from a recent maintenance grant; Health Life Safety monies; Impact fees; Sales tax revenues; and the District's O&M Fund. The board supported sending out RFPs for the stadium lighting project. The project is anticipated to take place this summer.

In other business at the March 19 board session, following closed session discussions, the board took actions related to personnel. 

You Can Cope with Turbulence... As a Passenger and an Investor

If you're like many travelers, you get a little nervous when your airplane goes through some turbulence. And if you're like a lot of investors, you may get somewhat jumpy when the financial markets are volatile. Yet flight turbulence probably isn't as scary as it seems, and the same may be true for market volatility — if you know how to respond.

Let's look at some positive responses to market movements:

Don't overreact to turbulence. Turbulence happens on most flights, but passengers are well aware that they can't "bail out" at 30,000 feet, so they generally don't panic. As an investor, you also need to avoid panicky behavior — by not taking a "time out" from investing. Over a period of decades, if you were to miss just a handful of the market's best-performing days, your returns could be dramatically reduced. And the best days often follow some of the worst. So if you're not invested in the market, you could miss out on the beginning of a new rally, which is typically when the biggest gains occur.

Balance your "cargo." The ground crew properly positions an airplane's cargo to maintain the plane's center of gravity and reduce the effects of turbulence. When you invest, you also need to achieve balance by owning a variety of vehicles, including stocks, bonds, government securities and certificates of deposit. You'll want your investment mix to reflect your risk tolerance, goals and time horizon. While this type of diversification can't guarantee profits or protect against loss, it can reduce the effects of "turbulence" — that is, market volatility — on your portfolio. Over time, your "cargo" (your investments) may shift, becoming too heavy in stocks or bonds relative to your objectives. Consequently, you'll need to periodically rebalance your portfolio to ensure it's meeting your needs.

Match your "transportation method" with your goals. If you are flying from New York to Los Angeles, you may experience delays or some changes in the flight plan — but your goal is still to reach Los Angeles as quickly and efficiently as possible. Consequently, you wouldn't scrap the idea of flying and head to the West Coast on foot. When you invest, you will also encounter events, such as market downturns, that you feel may be slowing you down in your progress toward your long-term objectives, such as a comfortable retirement. But if your objectives haven't changed, neither should your "transportation method" of reaching them. In other words, don't abandon your long-term strategy in favor of quick fixes, such as chasing after "hot" stocks that may not be suitable for your needs.

Maintain perspective on your "flight path." When you've flown, you've probably observed (perhaps with some envy) some of your fellow passengers sleeping through periods of turbulence. In the investment world, these types of people are the ideal long-term investors they know that turbulence, in the form of market fluctuations, is normal, because they've experienced it many times before. Their perspective isn't on short-term events, such as volatility, but rather on the voyage toward their "final destination" — i.e., the achievement of their

So when you fly, fasten your seatbelt and relax. And when you invest, don't overreact to short-term events. By following these basic guidelines, you will be a calmer traveler and a better investor.


go to the top 8.
