DEA 'Taste of Dwight'

- Updates -

Since announcing plans to hold the first "Taste of Dwight," the DEA has made several updates concerning the schedule of the event, as well as vendor-related issues. "Taste of Dwight," which plans to highlight local businesses around Dwight, as well as provide a time of fun activities for the community, will take place August 10, from 2 p.m. to 8:30 p.m., at Renfrew Park, Dwight.

Kicking off the live entertainment will be Sarah and Luke at 2 p.m., followed by Marcos Mendez, Scott Marek, Linds and Chad, and, finally, Pete Jive. Each will perform for about an hour, so there will be music throughout the entire event.

From 3 p.m. to 7 p.m., Kids Corner, which will have games, a scavenger hunt, and plenty of fun activities for children, will be available.

There will also be a beer

garden, in addition to plenty of non-alcoholic beverages being sold by various vendors.

Harvest Days Home Run Derby Tryouts will take place from 12 p.m. to 3 p.m., and will then be followed by three, hour-long Co-ed softball games.

There will be plenty of delicious food on hand from Dwight restaurants, allowing you to 'taste' some hometown favorites for a fee.

Vendors will begin set up at 12 noon.

To ensure guests visit the booths, the DEA is sponsoring Vendor Bingo. People at the event must visit the booth to fill the square on a card. This card will be provided by the DEA, and is a great way to starting a conversation.

Cost to set up a 10' by 10' booth varies, depending on the type of business. For

non-profit organizations, the booth is free. For non-food businesses and other organizations, the space is free to those with existing Dwight Economic Alliance memberships or a new membership. Restaurants need not pay for booth space, but DEA will receive a percentage of sales, which is detailed in the registration form.

In order to make things easier for restaurants selling food, the DEA will sell food tickets to be used for all transactions during the event. This will ensure staff will not need to deal with cash directly.

Even if, as a vendor, there is not anything readily suitable to sell, it is still a great platform to use to market the business to new and old customers.

On August 4, from 3 p.m. to 5 p.m., the Prairie Creek Public Library in Dwight will be having an Open House for the community to come and visit with Kristin Glatz and Bev Jensen, who are both retiring from their positions at the library this year.

It will also be an opportunity to welcome Sherri Rhoades, who will be taking over Kris' position as the new Library Director. The Open House, which has been planned by the Library Board, will include refreshments served by the Dwight Woman's Club, and plenty of do-you-remember, according to Glatz.

All three ladies sat down last Wednesday, gathered around a table in the children's section of the library they have all come to call their home away from home over the years. Fond memories were shared as the women looked back over the

time they had shared with each other, their staff, and the community they served.

Kristin Glatz, the current Director of the Prairie Creek Library, got her start as a volunteer at the old library in 1984. She began her official library career under Jane Broeksmit, and has been at Prairie Creek ever since. "I never went to work," Glatz commented, "I went to be with friends, and books."

Bev Jensen has been employed at the library for around 20 years, also getting her start as a volunteer only to be recruited later into a full-time staff member. She began her library career in 1994 under Anne Martin.

One of Glatz' favorite things about working at the library has been getting to work with children as they first began to discover the endless possibilities reading had to offer with every new book they opened. Her unique position as Director also gave her the opportunity to work directly with

community members, which meant she would get to see and interact with patrons each day, even outside the Library.

"I will also miss being able to order books," Glatz continued, who enjoyed picking out new and exciting reading material for library guests to explore.

For Bev, it will be working with the people she has grown to consider a family, in addition to having the ability to get a firsthand look at new books as they came into the library. "One of our running jokes was always that we needed to get bigger tote bags; working at the library meant you would be taking three books home when you already had ten books at home."

When asked about plans for their retirement, both were excited at the simple prospect of having more time to enjoy doing things they loved, and just not having to go to work. Glatz was





looking forward to putting less sewing projects on hold and enjoying her coffee in the mornings; Jensen couldn't wait to delve deeper into her historical and genealogical interests.

The biggest changes to the library since they have been there have involved updates to the way the library is run, to the emergence of new competition in the form of eBooks. "Organization of the interlibrary loan has changed drastically since I have been here," Glatz commented. "It used to involve putting mail in a bag, and now, with computers, it just takes a click."

In addition, computers have updated the way the card catalog operates, which meant the ladies no longer had to spend countless days and nights handfiling typewritten cards which attempted to help lead patrons to books they were trying to find. The new system allows patrons much more privacy, and they even have the ability to put books on hold from home.

"Computers have also streamlined the checking in/out process," Glatz commented, as the library's entire circulation is on computer. "I loved learn-

ing how to do new things once we got the computers," Jensen said. "It made things much easier and faster."

"The thing I have been most proud of while being the acting Director was the expansion of large print and young adult book sections," Glatz said. "The library Director is basically the CEO of the library," she continued. "You deal with the Library Board, purchase books, various administrative tasks; even take out the garbage."

Sherri Rhoades, who is the current leader of the Summer Reading Program, is taking over Glatz' role as Director at the library. She has been employed there over the past eight years, and has always been involved with the library because of her family's love of reading, so when an opening came about she jumped at the opportunity. "I'm really looking forward to being more involved with the patrons and getting to supply the library with materials," Rhoades said of her new position. "I'm just excited at the chance to have a more in-depth role."

"We have a top of the line library here in Dwight. We don't really have a Community Center, and our library has become a core gathering place for the

people of this community," Glatz said. "When we were looking for someone to fill my shoes, it was essential that we find someone who not only loved the library, but loved the community as well, and that is definitely Sherri. She puts 200% into everything she does."

Glatz was also extremely thankful for the wonderful staff, in addition to the board, which she described as, "fabulous."

"They cared deeply about the staff as well as the patrons," she said.

And, last, but certainly not least, Glatz has loved the patrons of the library. One of her favorite memories took place during a horrendous snowstorm; one so bad she was thinking of closing the library early. "But then, right as I was beginning to move toward the door, I saw a car pull up, and a 90-year old woman stepped out of the vehicle," she commented with a laugh. "I thought to myself, well I certainly can't close now, not if she was willing to venture out into the storm and drive all the way out here!"

The reason the woman insisted on braving the storm and driving to the library? She didn't want to be stranded without a book.



Dwight Lions Offer Program to Combat Deafness August 13

Deafness has no respect of age, wealth or rank -- it strikes people of all economic, social and age categories with equal frequency.

To help protect the hearing of the public through an early alert system, to increase public awareness not only of the problems of the deaf, but also the capabilities of the hearing impaired, the Lions Club of Illinois every year sponsors free hearing screenings for persons 18 and older, 10-17 years with written parental consent, in communities all over the state.

As part of that program, the Dwight Lions Club is sponsoring a screening from 9:00 a.m. to noon on Wednesday, August 13, at Dwight's downtown park, 132 E. Main St.

Hearing loss is probably the single most common chronic disability in the United States, occurring nearly four times as often as blindness. There are nearly 720,000 hearing-impaired people in Illinois alone. Of these, 106,000 are deaf; 26,000 of those were deaf before the age of 19.

Unfortunately, the problem is made worse since the deaf are least understood of all handicapped populations.

"For many years," said Jerry Gingery, Club President, "many associated deafness and stupidity together, even though deaf and hearing-impaired people have IQ's equal to those of

the hearing population." "The deaf have shown to be just as qualified as the hearing for job opportunities. They should be shown, and deserve, every consideration," added Max Sulzberger, Club Hearing Chairman. He noted that hearing loss takes many forms. In some, the problem is simply that they feel like the sound has been turned down. But others may have trouble in understanding various pitches or sounds. The causes, too, vary a lot, and there are many medical and mechanical treatments to help people with hearing loss.

"Since protection of our hearing is so important, we hope that the people of our community will take full advantage of the hearing screenings," Sulzberger adds. "The screenings take but a few minutes and persons who fail the screening are referred to hearing professionals for further evaluation and treatment."

The Mobile Hearing Screening activity is conducted through cooperation of the Lions of Illinois Foundation, the charitable arm of the state's more than 700 Lions Clubs and is funded primarily from Candy Day, held statewide the second Friday of every October.

A Food Sanitation and Safety course is being offered at Kankakee Community College in August. 



First Congregational Church Seeks Donations for Church World Service School Kits

As summer wanes and August begins, stores start to stock shelves with school supplies, signifying the arrival of a new academic year. Binders, folders, pens, and pencils spill out into the aisles, uniquely decorated for children to spot and pick out which design suits them as they return to school.

But what if a child's family couldn't afford these essential school supplies?

The mission committee for the First Congregational Church of Dwight has made it a goal to ensure that every child will have access to the basic tools necessary for learning. The Missions Committee, made up of Marilyn Hensel, Barb Jensen, and mission treasurer, Charles Johnson, participates in the Church World Service Kits program, collecting items to send in for assembly and

dissemination throughout the country.

Completed kits are sent to the Brethren Service Center in New Windsor, Maryland, or the Ferncliff Center in Little Rock, Arkansas, where they are then processed, sorted, and readied for shipment. The kits can travel as far as Africa, to aid refugee children, or even to children in the U.S. who have not been able to afford the supplies needed to continue their education.

"We will begin collecting items for the kits in August," stated Johnson. "In September, after Harvest Days, we will ship the kits out." Each kit must be prepared the same way, and a specific set of items is packaged into each one to ensure each child gets what is absolutely necessary to continue schooling. "I went shopping recently and got everything for the kit for less than \$10," said Johnson. "However,

people wishing to help don't have to turn in a complete kit; they can also just buy multiples of specific items needed for the packages," Johnson continued.

Listed below are the items needed to assemble a school kit:

- One pair of blunt scissors (rounded tip)
- Three 70-count spiral or tape-bound pads of 8" by 10 1/2" wide ruled paper, for a total of 200-210 sheets of ruled paper (please do NOT provide loose-leaf or filler paper)
- One 30-centimeter ruler (12"), flexible
- One hand-held pencil sharpener (2-in-1, so that pencils of different sizes can be sharpened)
- One large eraser (pink)
- Six new pencils with erasers (#2, hard)
- One box of 24 crayons

(only 24)

• One 12" by 14" to 14" by 16" finished size canvas bag with cloth handles

All items should be packed inside the cloth bag.

"The church secretary will be in her office on Tuesdays and Wednesdays so that any completed kits or items for the kits can be dropped off directly," Johnson said. "If no one is at the church, a message can be left on the machine concerning the kit or items by calling 815-584-1260."

"Even before I became the mission treasurer, I was interested in helping out with the missions at our church," Johnson explained. "An elderly member of our church made sure to stress the importance of keeping those in need at the forefront of our missions, and

it has stuck with me ever since."

Back-to-School Registration Dates and News

Odell Grade School Registration August 4-8

Registration for Odell Grade School is slated for Monday through Thursday, August 4 through 7, from 8:00 a.m. to 2:00 p.m., and Friday, August 8, from 8:00 a.m. to noon.

- Book fees are \$75 for grades kindergarten through eighth
- Athletic fee is \$25 for each participating student
- Snack milk for students in kindergarten through second grade is \$45 for the year
- Pre-pay meals are now available with a minimum deposit of \$20 on each student lunch account.
- Student lunches are \$1.75 for students (\$0.75 reduced)
- Breakfast will also be available at \$1.40 for stu-

dents (\$0.50 reduced).

A new health card or physical examination is required for preschool, kindergarten, and sixth grade students. All students entering sixth grade will be required to provide proof of Tdap vaccination. For any boy or girl who will be participating in sports, Illinois State law requires that all immunizations be up-to-date.

Dental exams are now required for students in grades kindergarten, second, and sixth. Eye exams are now required for students entering kindergarten and transfer students.

Transfer students must have health cards and records of immunization

sent to the school. All health cards and immunization records must be completed and returned by the end of September.

Athletes will not be allowed to participate in any sport until a physical exam is on file in the office.

All athletes participating in athletics and cheerleading must carry school insurance, or the family must sign a waiver furnished by the school that states the family has insurance, which provides for the student.
