Gardner VB Meets; Residents Share Information

The Gardner Village Board opened its regular meeting August 11 with resident Ida Schopp commenting she showed a family from Paris, France around the historic jail, and shared their positive comments regarding the display.

On the board agenda, Gardner resident Barb Baker addressed the board regarding what she referred to as abuses of the TIF fund. Baker provided the board with a packet of documents originally intended to be presented at the Board's May 27 special meeting, which Baker did not attend. The packet included several other documents in which she highlighted passages that were the subject of her concern. Baker commented that she did not believe making payments under the intergovernmental agreements to the Grade School, High School, and Fire Protection Districts could be considered redevelopment under the TIF act.

Village Finance and TIF Commissioner Dick Hileman commented the Village has consulted with both Village and TIF legal counsel regarding the payments to the Districts, including both annual payments and the funds

advancement to the Fire Protection District. Hileman also commented that he will try to provide the legal standing from the TIF Act, which allows borrowing from the TIF fund. Baker requested the board to provide specific portions of the law allowing the use of TIF funds for capital expenditures and expressed that she does not believe the board has the authority to share the TIF funds with the Districts under intergovernmental agreements.

The board discussed and approved an extension of the Village's agreement with the Gardner Church of Hope to allow the Church to retain the lot across the street from the Church as grass pending funds to complete paving as a parking lot. The original agreement was for five years and the Church has not yet raised the funds needed to pave the lot.

Commissioner Mike Serena presented a request from Cathy Petavino of VINO's to the board to allow the use of the downtown parking lot for a craft show on Sunday, September 7, from 9:00 until 4:00 p.m.; the request was approved.

The board entered executive session at 8:06 p.m.

Gerrymandering Effort Is Not Being Abandoned

A constitutional amendment to end gerrymandering (the unfair art of redrawing legislative districts every ten years to favor the Party in power) will not be on the November 2014 ballot in Illinois.

More than enough signatures were gathered to place such an amendment on the ballot, but courts found fault with some wording in the proposed amendment, and there were also problems with determining the validity of the necessary number of signatures (298,000). So the effort has been postponed.

Postponed. Not abandoned.

Yes for Independent Maps, the non-partisan statewide coalition which spearheaded the signature-gathering drive, is planning to correct the matters the courts challenged and have a referendum approved to place the anti-gerrymandering amendment on the ballot

in November of 2016.

Glen Ludwig of Bloomington, an area coordinator for Yes, for Independent Maps, lauded the effort of downstate people who solicited signatures this past year, and all those who signed the petitions to place the anti-gerrymandering amendment on the 2014 ballot.

Ludwig noted the majority of challenged signatures did not come from the downstate volunteer effort to gather names.

The planning process for the next campaign is expected to begin later this year.

Voters should watch for announcements as to where they can sign petitions that will get an anti-gerrymandering amendment on the 2016 ballot.

Voters will then have an opportunity to end the practice of gerrymandering before election districts are again redrawn in 2020.

Dwight Prepares for Harvest Days August 11 Village Board Actions

With the annual Dwight Harvest Days celebration drawing near, the Dwight Village Board of Trustees took several actions at its August 11 meeting in preparation for the event. This year's event is slated for September 19 - 21.

A Resolution to request permission from IDOT to close off Mazon Avenue from Old Route 66 to St. Louis Street between the hours of Noon and 4 p.m. on September 21 was approved. The closure is to accommodate the Harvest Days Parade. Traffic will be detoured during this time period. Another approved request will put a no parking restriction on the 100 block of East North Street and the

200 and 300 block of North Franklin Street from 7 a.m. to 3:30 p.m. on September 21 to accommodate the Harvest Days Car Show. Finally, a Sound Amplification Permit for use at Dwight's Renfrew Park for the September 21 Car Show from 8 a.m. to 3 p.m. was approved.

In his report to the board, Dwight Mayor Jared Anderson acknowledged the Dwight Economic Alliance for a "great job" with its first Taste of Dwight event which was held on Sunday, August 10, at Renfrew Park. Anderson called the event a "good time" with an "outstanding turnout" and also thanked the group for doing an excellent job of cleanup after the event.

Chief of Police Tim Henson again urged resi-

dents to lock their vehicles and keep valuables out of sight as car burglaries continue to be a concern. Henson reported that late night and early morning police bicycle patrols have resulted in several arrests.

The board approved a request to allow organizers of a campaign aimed at increasing awareness of ovarian cancer to place teal colored ribbons in the downtown area for the month of September. Turn The Towns Teal is a national campaign to increase awareness of this disease and its symptoms. September is Ovarian Cancer Awareness month. See related story on page 3.

The board also passed a Resolution to honor and recognize three outstanding DTHS FCCLA students for their outstanding achieve-

ment of earning gold medals at the 2014 Leadership Conference in San Antonio TX in July. Students Savannah Kline, Hannah Van Der Karr, and Ryan Bartz were recognized along with FCCLA Sponsor Mrs. Kathy Patten.

In other business, the board approved:

- two Fund transfers.
- spending up to \$9,500 for the purchase of a new mower at the discretion of the Public Works Department.

The board entered Executive Session with regard to the purchase or lease of real estate - litigation. No action was taken.

The next meeting of the Dwight Village Board will be Monday, August 25, at 6:30 p.m. in the Public Services Complex.

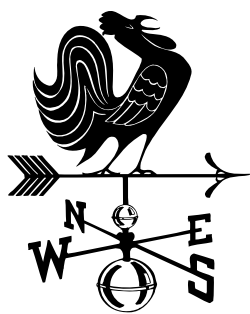

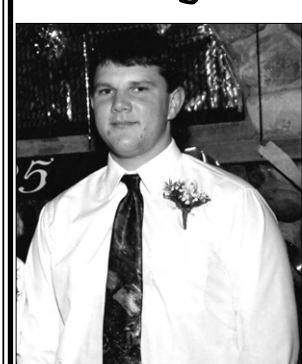

Two Bats Found in Iroquois County Test Positive for Rabies

The Iroquois County Public Health Department is working with the Illinois Department of Public Health's Division of Infectious Diseases and Iroquois County Animal Control in response to laboratory confirmation of a second bat found in Iroquois County to be positive for rabies. The first bat was obtained in the Cissna Park area in May. The second bat testing positive through the Illinois Department of Public Health's State Laboratory was found in the Watseka area last week.

The bat is the primary carrier of rabies in Illinois. Although there are many misconceptions, rabies is transmitted to humans when saliva from a rabid animal gets inside the body of a person, typically through a bite or scratch from the animal. Bats flying above a person's head would not pose a risk for rabies for that person.

The Illinois Department of Public Health has issued the following tips that can help prevent the spread of rabies:

- Be a responsible pet owner. Keep vaccinations up-to-date for all dogs, cats and ferrets. This requirement is important not only to keep your pets from getting rabies, but also to provide a barrier of protection for you if your animal is bitten by a rabid animal.
- Keep pets under direct supervision so they

do not come in contact with wild animals. If your pet is bitten by a wild animal or exposed to a bat, seek veterinary assistance for your pet immediately.

- Call the local animal control agency to remove wild or stray animals in your neighborhood. Iroquois County residents should contact Iroquois Animal Control at 815-432-6985.
- Avoid direct contact with unfamiliar animals. Do not handle, feed or unintentionally attract wild animals with open garbage cans or litter.
- Never adopt wild animals or bring them into your home. Do not try to nurse sick animals to health. Call animal control for assistance.
- Teach children not to handle unfamiliar animals, wild or domestic, even if they appear friendly. "Love your own, leave other animals alone" is a good safety principle for children to learn.
- Prevent bats from entering living quarters or occupied spaces in homes, churches, schools and other similar areas where they might come in contact with people or pets.

All I-55 Lanes Now Open Over Des Plaines River

Illinois State transportation officials announced Friday both south- and northbound lanes of Interstate 55 over the Des Plaines River are now open.

Northbound lanes opened Thursday and Southbound lanes opened Friday.

Intermittent night-time lane closures will continue to complete work on and near the bridges.

The reopening of I-55 comes just weeks after five people, including two from the area, died as a result of a July 21 collision involving a

semitrailer in the I-55 construction zone. A second collision that same day resulted in the death of a sixth man.

included repairs to the twin 58-year-old truss bridges' pier, abutment and structural steel, along with new decks and a paint job.

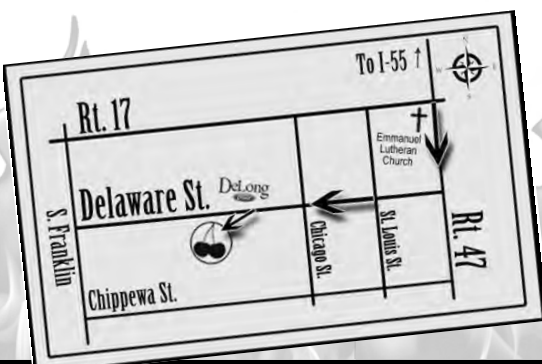

Study Reveals Racial Profiling in Illinois Consent Searches

It's been 10 years since Illinois began collecting data about every traffic stop in the state as a means of curbing racial profiling, and a new study suggests it's not working.

Using data from 2013, the ACLU of Illinois found African American and Hispanic drivers are nearly twice as likely to be subjected to consent searches as white drivers, while white drivers are more likely to be caught with contraband.

ACLU senior lawyer Adam Schwartz says it's a troubling problem that needs to be addressed.

"Enough is enough," he stresses. "The technique ought to be abolished. Police simply should not be in the business of asking people for permission to search their cars."

The report also noted racial disparity in the use of drug-sniffing dogs, and found the Illinois State Police was more than twice as likely to conduct a dog sniff on a stopped vehicle driven by a Latino than on a white motorist.

Yet, the study showed white motorists were more than 60 percent more likely than Latino motorists to be found with contraband in a trooper search that followed a dog alert.

Schwartz says there is an inherent problem with consent searches because often they are not truly voluntary.

He says many motorists believe they must grant consent, while others fear there will be consequences if they refuse.

"We've heard reports where the consent is refused and the officer says, 'OK, we'll do this the hard way and we're going to hold you for a few minutes until the dog arrives and we're going to walk a dog around your car,'" he says.

"So technically everyone's got the right to refuse, but in practice sometimes the police lean on people."

The Illinois Traffic Stop Statistical Study Act of 2003 was passed as an effort to reduce racial profiling and legislation passed earlier this year extends the collection of data for another five years.

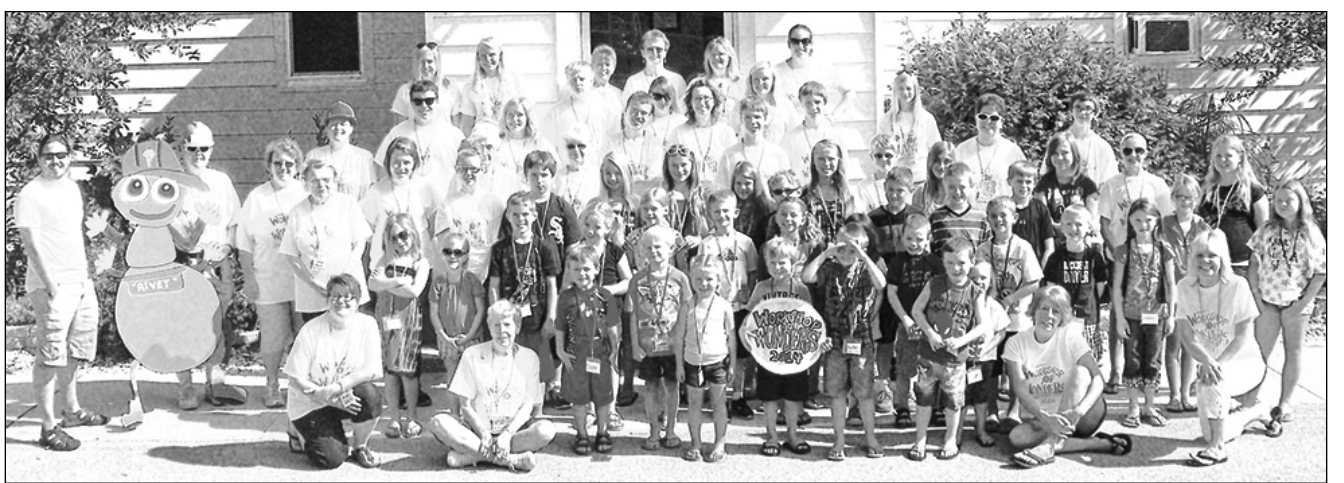

Avoid Expensive Errors When Paying for College

It's just about Back-to-School time again. If you have young children, you might be hustling them to the store for backpacks and binders. But if you fast-forward a few years, you can envision driving your kids a little farther — to their college dorms. And when that day comes, you'll want to be financially prepared. So you'll want to avoid making costly mistakes when preparing for, and paying, those big bills. Here are some of the most common of these errors:

Not saving enough — Only half of all families with children under 18 save any money for college, according to a recent study by Sallie Mae, the country's largest originator of federally insured student loans. You might find it easier to save for college if you automatically move a set amount each month from your checking or savings account to a college savings vehicle.

Not considering vehicles with growth potential — The same Sallie Mae study found that more parents use a general savings account than any other method of saving for college. But since most savings accounts these days pay only a minimal rate of return, you will have trouble getting the growth potential you need to achieve your college savings goals. Consider working toward your college savings goals by investing in a vehicle specifically designed for college, such as a 529 plan or a Coverdell plan. There are differences between these plans, such as contribution limits and tax treatments, but both allow you to invest for growth potential. As with any investment account, there are risks involved, including market risk.

Stopping your savings once your children are in college — Unless your children plan to take an awful lot of credits, they're not going to finish college in just one year. Consequently, you'll want to keep investing in your plan or other college savings vehicle while your children are in school.

Taking out 401(k) loans — Your employer may allow you to take out a loan against your 401(k) to help pay for college. But this may not be a good idea for two reasons: First, when you remove money from your 401(k) — even if you plan on eventually paying it back — you will slow the potential accumulation in your account, thereby depriving yourself of resources you will eventually need for retirement. Second, should you leave the company, you might have to repay the loan within a limited number of days.

Not using available tax credits — Depending on your income, you might qualify for the American Opportunity tax credit, which is worth up to \$2,500, provided you spend at least \$4,000 on college expenses. Check with your tax professional to see if you qualify for this credit and how to most effectively incorporate it. And be careful you don't waste the credit, because you may not be able to use it and your plan distributions at the same time.

Paying for college can be challenging — but if you can avoid making the above mistakes, you've got a better chance of getting your kids through school without derailing the progress you'd like to make toward your other financial goals.

When you enter a restaurant you expect to be greeted, offered some choice in seating, and to be served what you came for: a nice meal in a pleasant atmosphere. Even if it is 'fast food' you come and go with expectations which meet your need and desires.

In some ways church can be experienced in this way, one comes as consumer of the spiritual meal which is offered through song, words of scripture, message connecting God's faithfulness to our lives, and prayers.

In a restaurant one can passively eat the food alone, or while enjoying the company of spouse, friends, and family. Often the case with fast food, it is pleasing and satisfies the necessary purpose of providing substance and hopefully nutrition. In a finer restaurant you may additionally be more attentive to the savory qualities of the food in its preparation and presentation; the complementary nature of beverage and side dishes.

The primary role of the church is to satisfy the hunger of the human soul. When this hunger is satisfied as the Lord created and provides; the gifts we receive spill out into the community

through the lives, hopes and dreams made possible because we are not depending upon ourselves alone. The substantive and nutritional means of grace: God's real presence, mercy and peace giving love become visible and effective in the lives of people like you and your neighbors. That is when one does not accept substitutes for what relationship with God alone can satisfy.

Serving God's real presence is the goal of worship services and many factors contribute to how well this goal is more or less met. Faith development, commonly known as Sunday school, has the goal of providing foundation and structure for applying spiritual truth and faith in God to daily life and strong supportive community.

"Where is that served?" you may be asking. One of the factors confounding enjoying a good spiritual meal is appetite. The fast pace of life and unfamiliarity with how the substance and nutrition are received through God's word, prayer, and someone using ancient history as a reference point leave undeveloped the spiritual appetite of many. Yet, most of us know music which feeds us spiritually. I don't know a pastor or priest who does not want to serve a satisfying

meal of the Good News and provide opportunities to cultivate your taste buds to distinguish and appreciate the substance and nutrition God desires to provide that your life might be abundant in spiritual fruit now and enjoyed eternally. You might go and talk with your pastor or priest, or one a friend knows, if this article has aroused an appetite in you.

I am one who grew up in the church and did not cultivate more than a passive appetite for the spiritual nourishment until I experienced my faith lacked the substance to sustain me through life's trials. Having found all the world offers could not support health or provide the healing I needed. Then I asked God for the promises I heard in church to be true for me as it is for those who actively believe and practice faith in God. I no longer wanted to be passive towards the Lord's faithfulness, rather clothe myself with faith.

Years later I now serve as pastor of St Peter's Lutheran on the corner of Chippewa and Lincoln in Dwight. We are listed in the church directory printed in "The Paper" and encourage you to dine upon the spiritual fare offered at the churches serving your community.





Chatsworth Corner

The Town of Chatsworth meeting was called to order by Mayor Richard Runyon at 7 p.m., August 14. All board members were present and the minutes were approved. The sheriff's report included 57 calls in the previous month, with 11 citations including one DUI and five written warnings including two ATV violations.

Old business included information regarding the number of stop signs in the town limits. Mare Reardanz submitted a map of the town with all 140 stop signs clearly marked. She also presented a list of citizens that supported the change in stop sign numbers. The excessive number of stop signs reduce fuel efficiency, increase noise pollution and wear and tear on brake systems.

They also have been known to encourage drivers to ignore the law. According to Illinois State research, stop signs do NOT decrease speeding throughout the town. Impeding traffic flow is contraindicated by excessive use of stop signs. Mayor Runyon asked Trustee Will Price to ask his committee to review the situation and report back with their findings.

Mr. Jeff McMillan came and informed the town that the insurance for the year would be reduced for the next year due to fewer workman's comp claims. He reminded us that there is additional insurance available for major equipment repair. The town declined the extra added coverage at this time.

Mayor Runyon informed the Board that the town is in need of a flat filing cabinet to hold the plans that are currently all rolled up and getting old and brittle. A new cabinet is being contemplated for \$800. This cabinet is not fire safe, and Trustee Dale Diller suggested digitizing the plans and having them on computer rather than stored. He offered to look into this service.

The Attorney's report stated that the owners of abandoned properties are being contacted to inform them that the properties will be taken over by the town and demolished.

Town stickers for golf carts are now legal to display attached to the driver's side windshield or the back of the cart.

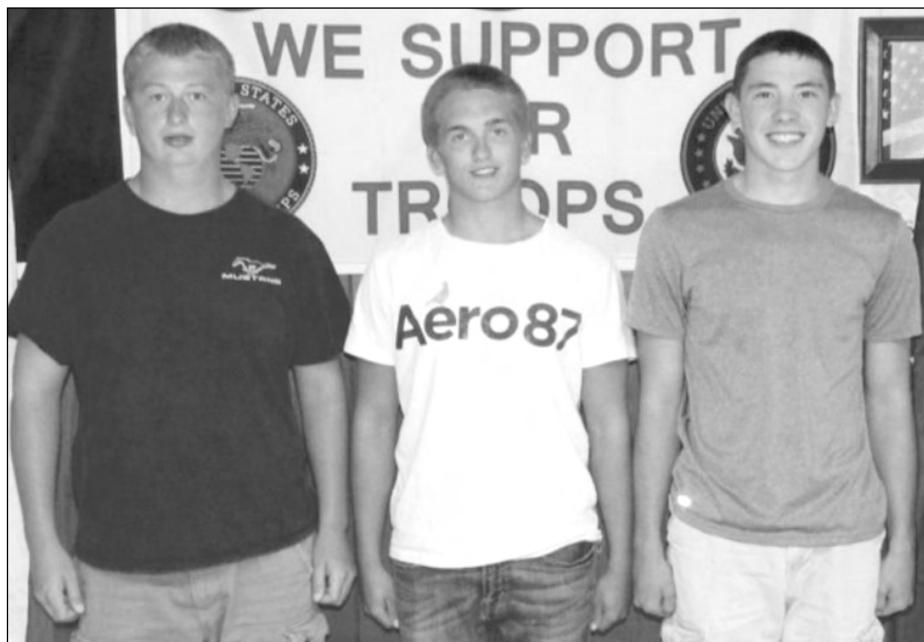

WHEREAS, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics, and other workers employed in any public works by the State, county, city, or any public body or any political subdivision or by any one under contract for public works," approved June 26, 1941, as amended being Section 130/9, Chapter 820, Illinois Consolidated Statutes, 2000; and

WHEREAS, the aforesaid act requires that the Village of Odell, Livingston County, State of Illinois, investigate and ascertain the prevailing rates of wages as defined in said act for laborers, mechanics, and other workers in the locality of said Village of Odell employed in performing construction of public works for said Village of Odell, State of Illinois.

SECTION 1. Most of the Rotarians and guests who listened to Gary Olson talk about the Shelter Box charity had never heard of it. Now they will notice the logo on the tents in the Syrian War Refugee Centers and current pictures in Haiti. Old shots can be on websites and news broadcasts of the Indian Ocean Tsunami survivors, and Katrina tent

cities. Each \$1,000 box is packed with a family-sized tent, thermal blankets and ground sheets (additional for colder climates), water storage, purification equipment, solar lamps, cooking utensils, basic tool kit, mosquito netting, and a children's activity pack. The boxes are stored in warehouses around

the world. As soon as a disaster which meets the needed criteria is found on news broadcast social media, or by request, boxes and volunteers are on the way. Volunteers are sent to show refugees how to erect the first tents, layout the tent cities, and use the other items. Often the refugees have never "roughed it" and

must be trained to "camp out." They organize the new community and set up schools and activities for the children. Additional packs are sent later for setting up schools.

Dwight Rotarians have taken on Shelter Box as their primary charitable project. Rotarians Dale Adams and Pastor Randy Randle are available for programs with a DVD explaining the Shelter Box organization. The club is hoping to have a demonstration box at the Harvest Days' Flea Market.
