## Greenfield Township Honors its Veterans with New Memorial

Veterans from Greenfield Township in Grundy County will never be forgotten thanks to a new memorial to be dedicated July 29 at South Wilmington VFW Park during the annual Party in the Park.

The nearly 6-ton memorial includes names of those who served in the Armed Forces and lived in Greenfield Township, said Bill Simms, a South Wilmington board member who helped spearhead the project.

It's been decades since Greenfield Township has had such a memorial. Simms said that on Oct. 8, 1944, the "Honor Roll" was dedicated near South Wilmington City Hall. Names of those who served in both World Wars were painted on a metal wall. In time, it was dismantled.

But Rick Marketti, of Gardner, and his brother, Grundy County Sheriff Terry Marketti, had talked extensively about bringing the memorial back before Terry's death in December 2012. A year later, on Super Bowl Sunday, Simms, Rick and Rick's wife Donna decided to push the project forward.

They got to work, found an army of volunteers willing to help, and raised \$40,000. Funds came from donations and sales of 4x8-inch granite bricks that create the sidewalk leading up to the memorial. The bricks are \$100 and can be engraved in memory of a family member or friend.

It took five years, but now an 11,000-pound, 9 1/2-foot, five-sided granite memorial includes the names of some 300 veterans, both men and women, both deceased and still living. Simms said the

majority of names came from the original memorial, but they scoured for veterans of the Korean, Vietnam and Afghanistan wars and recent wars through letters and word of mouth.

Among the names are Greenfield Township's last remaining World War II veteran, Michael "Plow" Joyce, who died in March. The memorial includes plenty of space for more names to be engraved, and even includes a separate granite stone dedicated to

Terry Marketti.

All the labor for the memorial was donated by people in the community -- countless individuals who were there from the beginning, from collecting names to the final engraving. Carpenters Local #916 donated time and materials to build the pavilion that covers it.

Simms said no one who worked on the memorial wants recognition. Rather, they see it as their duty to their country and those who fought for freedom.

"This is about the names of people who are up there who had to go and fight," he said.

Greenfield Township saw five residents killed in World War II, two in Vietnam and three were taken as POWs. The dedication will take place at 3:15 p.m. at 5th and Lemmon Street. Those eight men will be remembered, the story of the memorial will be told, and there will be recognitions and a blessing by Father Stanley Drewniak of St. Lawrence Cath-

olic Church in South Wilmington.

Rich Alderson, village president, sounded proud of how the community came together for the memorial. Alderson, whose late grandfather John Alderson served in WWII and whose name is among those engraved, volunteered installing the electrical for the memorial. There are spotlights, overhead lights and lights lining the walkway.

"Come out and see it," Alderson said. "It's a beautiful memorial."

**Where You Live as Retiree Can Affect Financial Strategies**

Upon retiring, many people relocate to enjoy a more favorable climate, or to be closer to grown children, or to live in an area they’ve visited and enjoyed. If you, too, are thinking of moving someday, you’ll want to study possible locations, but you also need to be aware that where you eventually decide to live can greatly affect your savings and investment strategies – both now and during your retirement.

**Here are some relocation costs to consider:**

**Housing** – Not surprisingly, the larger the city, the more expensive the housing is likely to be. Also, locations near an ocean or the mountains tend to be more costly. But the type of housing you select – house, apartment or condominium – also can affect your financial picture in terms of initial expense, maintenance and possible tax benefits. Plus, you can now find newer types of arrangements, such as senior cooperative housing, in which you own a share of the community and have a voice in how it’s run.

**Health care** – If you are 65 or older when you retire, you’ll have Medicare to cover some of your health care costs, though you’ll still likely need to purchase some type of supplemental coverage. The Paper Has Petitions for Livingston County Home Health Care

Petitions to place an advisory referendum on the November 6 ballot for continuing to fund the Community Health Care Program in Livingston County are now available at *The Paper* in Dwight.

All registered voters in Livingston County are eligible to sign the petition, which asks:

“Shall the Livingston County Board maintain an adequate Public Health budget to provide county residents with the support they need to experience and maintain independent living?”

In July of 2017 the Livingston County Board voted 13 to 4 (7 were absent) to terminate the county’s Community Health Care Program on November 30, 2018.

The program has been in effect since October of 2009 with county funding. Recipients were charged a sliding scale depending on their income. The county funding for the program in fiscal year 2017 was \$220,942.

Petitions must be completed by August 3 to be submitted by August 6.

## Farm Bureau Foundation Awards \$10,000 to Scholarship Recipients

Joseph Buckley is a Herscher High School graduate and is the son of Gregory and Edith Buckley. Joseph plans to study Agriculture Production & Management at Joliet Junior College.

Madison Orr is a graduate of Herscher High School and is the daughter of William and Sherri Orr. Madison plans to study Crop Sciences at the University of Illinois.

The scholarships were offered to high school seniors who either live in Kankakee County or are members of a Kankakee County Farm Bureau member family, and are accepted to an accredited post-sec-

ondary educational institution with an agriculture related field of study.

Accredited post-secondary schools include colleges, universities, junior colleges, and technical and vocational schools. After meeting the initial criteria, the applications were assessed on four categories: demonstrated interest in agriculture and agribusiness, character and personality, academic performance and honors, and financial need.

Due to generous donations and contributions, the County Farm Bureau Foundation was able to award four Kevin Yohnka Memorial Renewable Scholarships to students in his or her second year of post-high school agriculture-related studies. ## Commentary

### Mautino story sad for all concerned

Illinois Auditor General Frank Mautino was a State Representative from the 76th District for nearly 25 years. He was well respected, following in the footsteps of his father, Frank Mautino Sr.

Frank Jr. was named, and unanimously approved, for the position of Illinois Auditor General January 1 of 2016, about the same time that a couple of “watchdogs” in Southern Illinois noted very unusual campaign spending by the younger Mautino and his campaign committee while Mautino was still a State Representative.

The Edgar County “watchdogs” made note of more than \$225,000 from 1999 to 2015 that had been spent at a Spring Valley gas station, and more than \$150,000 at a Spring Valley bank, all very questionable expenditures because of the amounts, and also because of the lack of documentation.

The State Board of Elections didn’t notice anything out of order until citizen David Cooke of Streator, formerly of Dwight, filed a formal complaint about the expenditures.

The State Board of Elections found Cooke’s complaint to be “justifiable.” Mautino and his campaign committee went on the defensive, not supplying the Board with requested documentation, stating that records had been destroyed, and that they had done nothing wrong.

They, and their lawyers, had one hearing after another postponed for more than a year, until finally being charged with willfully refusing to furnish information requested by the State Board of Elections.

Mautino himself never appeared before the Board of Elections.

Mautino and his campaign committee

were fined \$5,000 -- which hasn’t been paid because the campaign committee is now defunct.

The Board of Elections voted in partisan manner to end any further questions or investigations regarding Mautino’s campaign spending — four Republicans cast votes to continue with the investigation; four Democrats voted to end the investigations.

Legally, the tie vote wrote finis to the matter.

However, Cooke, and his lawyers from the Liberty Justice Center, were not satisfied with ending the matter while the actual merits of the case — the suspicious campaign spending by Mautino and his committee — had not been heard.

They appealed, and the 4th District Appellate Court in Springfield told the Board of Elections it had to address the substance of the complaints filed by Cooke.

The result? Another tie vote on whether or not Mautino’s campaign committee was guilty of violating the Illinois election code.

The Illinois Policy Institute editorialized last week that “If Frank Mautino Didn’t Break the Rules, the Rules are Broken.”

Well stated. The toothless Board of Elections seems to have been nothing more than a depository for filed campaign expenditures, no matter the nature of those expenditures, no questions asked.

In this case, citizen David Cooke had to substitute for the lack of attention shown by the Board of Elections.

Cooke and his lawyers from the Liberty Justice Center in Chicago deserve some applause.

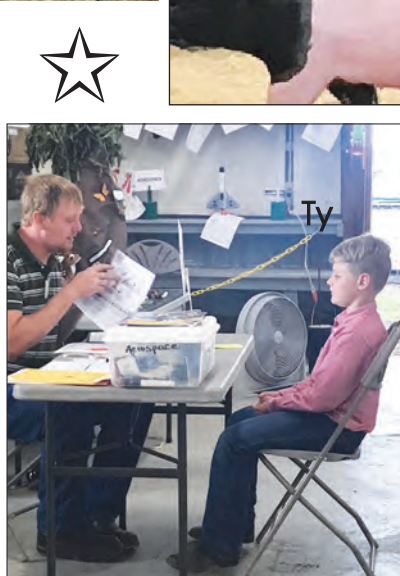
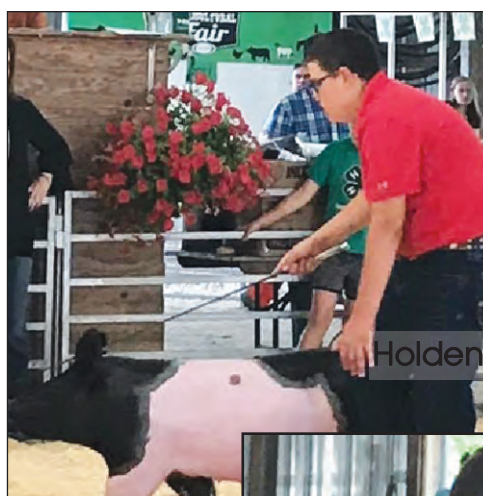
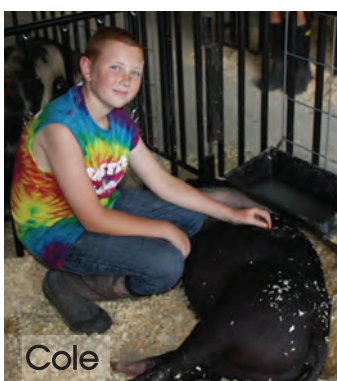

### Patti Bellock named DHFS director

Gov. Rauner has named Patti Bellock as the new director of the Illinois Department of Healthcare and Family Services (DHFS). Bellock has served in the Illinois House since 1999. She has established herself as one of the House's leading experts on Medicaid as well as the health care and social services programs she will oversee as director.

Director Felicia Norwood resigned earlier this year to take a job in the private sector. The interim director was Teresa Hursey, who will stay on as Medicaid Director in the Department.

As a representative from DuPage County, Bellock became the first woman to serve as Deputy Minority Leader in 2013. She played a major part in getting federal approval of the proposed Better Care Illinois program, the state's new effort to create 10 pilot programs on mental health and substance abuse. Rep. Bellock was also a driving force behind the updated hospital assessment earlier this year, a change which benefits our area by helping our local hospitals.

Originally from River Forest, Bellock has a bachelor's degree in History and American Government from Saint Norbert College in Wisconsin. She has been honored by numerous organizations over the past 19 years for her work on a wide range of health care policy issues, focusing on mental

health, developmental disabilities, and children's health.

The appointment took effect on July 11.

### Flood Alliance continues its work

We held our initial East Central Illinois and West Central Indiana Flood Alliance Meeting in Forrest earlier this month. Approximately 45 local leaders from Illinois and Indiana as well as flood management experts from both states were in attendance. We were also joined by representatives of the offices of Congressman John Shimkus and Congressman Adam Kinzinger. This is truly an issue that requires attention at the local, state and federal levels.

We covered a number of topics at a high level, including mitigation planning, flood insurance, obtaining funds and how groups might work together to gain more financial support for their efforts.

Special thanks go to our county board chairmen: Robert Young (Livingston County), John Shure, Andy Wheeler, Mike Marron, Randy Berger and Stan Glazier for their leadership. They helped bring together leaders in emergency management, soil and water districts, drainage districts, townships, county engineers, mayors and others who have an interest in protecting our area from flooding. I am also grateful to Paul Osman and his team at the Illinois

Department of Natural Resources for helping us to get organized.

The group will meet again to continue our efforts. Everyone's continued involvement is critical to helping this move forward.

### How much do we owe?

As of the time of this writing, the State of Illinois owes \$7,735,994,204 in unpaid bills to state vendors. This figure represents the amount of bills submitted to the office of the Comptroller and still awaiting payment. It does not include debts that can only be estimated, such as our unfunded pension liability which is estimated to be more than \$100 billion.

### Illinois Economic Report published

The Illinois Department of Employment Security (IDES) has published the "2018 Illinois Economic Report," a database which can be used to create a statistical picture of where Illinois currently stands and what our near-term future prospects are. As part of its overall responsibilities as administrator of Illinois' system of unemployment insurance, IDES is constantly collecting job-related information and insurance contributions from Illinois employers.

According to the report, Illinois is close to what economists consider "full employment" now that statewide unemployment has dropped to 4.3% in May, the most recent month for which statistics were available at the time of publication. The report also offered this cautionary note: new jobs are not being created in Illinois as quickly as they are being created in other states. The report divided the state into ten geographical regions and then used the job figures compiled by IDES to look specific economic and employment categories within each region. It then used that analysis to report on the strengths and weaknesses of each area.

### Did You Know?

While Illinois is the 6th largest U.S. state in population, we are ranked right in the middle of the nation, #25, in terms of physical size. At 57,913 square miles, Illinois is slightly larger than Iowa and slightly smaller than Georgia. While the biggest U.S. state in land area (Alaska) is more than 11 times our size, we are 37 times larger than the smallest state, Rhode Island.

**New to DTHS will be the use of credit card payments:** This will be a secure process using **Rev Trak**, which is a secured credit card vendor.

**Students new to the district:** **Tuesday, August 7th** – registration will be held from 9:00 a.m. to noon in the High School Office for new students who have never been enrolled in District #230 or District #232. State law requires new students to take a copy of their birth certificate when registering. Paperwork and fee payment will take place at this time.

**Returning students – Schedules and Payment:** Parents/Guardians of returning students will begin this process by logging into their student's Skyward account (July 23 through August 9) as they have done to check grades and communicate with the school with the login information from the previous year. Once logged into Skyward, you will see a new tab labeled **"Required Paperwork."** Parents/Guardians must click on this tab and complete the required paperwork. Fees must be paid online July 23 through August 1 or in person/online August 2-9 for registration to be complete.

**No Internet?** If you do not have internet access, you may complete the required online forms and pay online or in person at the High School on: August 2, 3, 6, 7, 8, and 9, 8:00

a.m. to 3:00 p.m.

**Important Dates and Times**  
• **Thursday, August 9 • Freshmen Orientation:** (Students only) will be held in the Auditorium from 11:00 a.m. to noon.

**Monday, August 20,** will be the first day of school for students. Classes will begin at 8:10 a.m. and dismiss at 3:10 p.m.

## School Fees

Two school-approved combination locks are to be purchased by incoming freshmen. One is to be placed on the student's hall locker and the other for the physical education locker. A fee for the two locks applies.

Other student fees include: Behind the Wheel Driver's Education Fee, Textbook Rental (required by all students), Activity Fee (required by all students), P.E. Uniforms, Participation fee (athletics, cheerleading, band, and Flag corps).

## Fees are Due at Registration

Students/Guardians may also be required to pay other fees for consumable workbooks or project fees for supplies and materials depending upon courses for which they are enrolled.

Parent/Guardians will be required to supply the following information at registration: name of health insurance, parent's place of employment and

phone numbers, family physician and phone number, adult to contact in case of emergency (if parent/guardian cannot be reached), e-mail.

State law requires students entering ninth grade and students new to the district (at any grade) to present evidence of physical examination and immunization records. Students entering ninth grade will be required to show proof of current immunizations including Tdap, MMR, polio, hepatitis B, and two doses of Varicella vaccine or a health care provider's indication of a past case of chickenpox. A **new law** states that all students with a diagnosis of asthma have their doctor provide an asthma action plan to the school. Students failing to present evidence of physical examinations and immunizations will not be allowed to enter school until these requirements have been met. Physical exam forms are available in the high school office.

**Incoming seniors:** All students entering 12th grade (seniors) will be required to show proof of meningococcal conjugate vaccine (MCV) upon school entry. This law is to prevent a severe form of bacterial meningitis. Some students have already received a meningitis vaccine. If the vaccine was received after age 16, only one vaccine is required. If the vaccine was received prior to age
