Stars and Stripes for Veterans

If you drove past Dwight Common Grade School this weekend, you would have seen a lawn of red, white and blue -- American flags, 454 of them.

And if you were at Dwight Township High School on Friday, you would have met some 44 veterans who were invited for the school's annual honor ceremony.

The community came together to honor those who have served or are currently serving in many ways this Veterans Day. And the flags at the grade school couldn't be missed.

The flags represent the names of veterans submitted by students, faculty and staff at the grade school. Each had a label with a veteran's name.

The flag display is in its third year, a project lovingly created by fourth-grade teacher Samantha Bastian, of Dwight. She's taught at the grade school for 11 years.

In August 2004, her brother, Lance Corporal Nicholas Morrison, was a Marine stationed in Iraq when he was struck by a roadside bomb. He died at age 23.

The flags were put up on Friday with the help of staff, students and their parents. They were taken down Tuesday.

Bastion said the display has grown tremendously in the last three years. The first year they had 136 flags. Even though names repeated, the second year it grew to 436. And the 454 flags that were put out this Veterans Day is only expected to grow.

"Now it's become a tradition we hope to continue," Bastian said.

Through \$1 donations from students, as well as Bastian's family, they have been able to purchase 900 flags, every one of which Bastian hopes will one day decorate the lawn of the grade school.

The Veterans Day ceremony at the high school is in its seventh year, started by Principal Dan Kaiser and Jan Schreiner from the Ladies Auxiliary of the VFW.

Forty-four veterans were honored. They came from local nursing homes, the VFW and, as in past years, 13 students brought a veteran they knew. Veterans were introduced at the microphone with their name, branch and station and were asked a question about what it was like to serve in the military. One veteran commented that, after 40 years, he still keeps in touch with some of his fellow soldiers in Vietnam.

"It was the best turnout of veterans we've had," Kaiser said.

They were fortunate to have two World

War II veterans in attendance, Ron Wilder can attend. The event is held not only to and Lester Peters, both from Heritage honor veterans and have their first-hand Woods nursing home in Dwight.

Each year Kaiser and Schreiner choose a graduate of DTHS who served in the military to come back and speak. This year it was Brian Trainor, of Dwight, a 2000 DTHS graduate and former Marine.

The program is held at the end of the school day, Kaiser said, so the student body

experiences heard, but also to give students a chance to thank them personally. The bell may ring, but students always stay and shake each veteran's hand.

The Dwight Veterans War Memorial was also put up to see. Students helped set up the heavy metal panels and take them down.

Jensen: New Initiative Could **Help Teacher Shortage**

November 1 was a big day at Dwight Township High School as Lindsey Jensen, 2018 Teacher of the Year and DTHS educator, introduced an innovative program that could help tackle the teacher shortage.

More than two dozen attended the meeting, including some of the top educators in the state. There were university professors, and Illinois Education Association representatives. Tony Smith, Illinois state superintendent of schools, and Jason Helfer, Illinois deputy superintendent of schools, were also in attendance.

A teacher at Dwight for 10 years, Jensen spoke about a national program called Educators Rising. As Teacher of the Year, she had to have a platform and chose teacher recruitment.

Jensen said there is a shortage of teachers, both in Illinois and nationwide.

According to a report from the Illinois Association of Regional Superintendents of Schools, superintendents in 56 percent of the districts surveyed believed that they have a minor problem with teacher shortages. However, when combined with those who believed they have a serious problem, 78 percent said they have some degree of a problem with teacher shortages. The report also found that 65 percent of superintendents believe that they have received significantly fewer applicants than five years ago. The problems appear most pronounced for bilingual and foreign language teachers as

well as recruitment of school psychologists. "I firmly believe teachers are underpaid and undervalued," Jensen said. "Teaching is the foundation for all other career paths. It is the most important job in the world."

It all starts with getting more kids to choose education as their career choice. As Teacher of the Year, Jensen traveled to Palo Alto, Calif., to observe the Educators Rising program in motion. Educators Rising has a national affiliation, but many schools simply use it as a club model.

Educators Rising cultivates highly skilled educators by guiding young people on a path to becoming accomplished teachers, beginning in high school and extending through college and into the profession. It lays the foundation for education courses, methodology, supervised clinical experiences.

Jensen would like to see it implemented statewide as a curricular model, an optional elective for high-schoolers who know they want to become teachers or for those who want to learn leadership skills, which may lead them to want to become teachers. It

could be taught as a semester or even a two year program, she said.

State Superintendent Smith was unavailable for comment on Jensen's presentation.

Jensen called the teacher shortage a "dire situation." The report by the Illinois Association of Regional Superintendents of Schools showed that Kankakee County, and many others, has a serious problem when it comes to teacher recruitment. Livingston County, it reported, has a minor problem.

Time to Think About **Year-End Investment Moves**

We've still got a couple of months left in 2018, but it's not too soon to start thinking about some year-end investment moves that might benefit you. Here are a few possibilities (although not all will apply to your situation):

Add to your IRA. For the 2018 tax year, you can put up to \$5,500 into your traditional or Roth IRA (assuming you are eligible), or \$6,500 if you're 50 or older. If you haven't reached this limit, consider adding some money. You have until April 15, 2019, to contribute to your IRA for 2018, but why wait until the last minute?

Increase your 401(k) contributions. You already may be investing in your 401(k) or similar employer-sponsored retirement plan, but you might be able to bump up your contributions for the rest of the year, if it's allowed. Of course, you should always put in enough to earn your employer's matching contribution, if one is offered.

Take your RMDs. If you are 701/2 or older, you must start taking withdrawals - called required minimum distributions, or RMDs - from your traditional IRA and your 401(k) or similar retirement plan. Generally, you must take these RMDs by December 31 every year. But if you turned 70½ in 2018, you can wait until April 1, 2019, until you take your first RMD. However, you will then have to take a second RMD (the one for age 71) by December 31, 2019. Taking two RMDs in one year could give you an unexpectedly large taxable income for the year, possibly bumping you into a higher tax bracket and affecting the amount of your Social Security benefits subject to taxes. So, if you are considering delaying your first RMD, consult with your tax advisor.

Make changes in response to life events. In 2018, did you experience a major life event, such as a marriage, divorce or addition of a child? Or did you change jobs or retire? Any of these events could lead you to adjust your investment plans, so now may be the time to do so, possibly with the help of a financial professional.

Review your investment mix. At least once a year, it's a good idea to review your investment mix to ensure it's still suitable for your goals and risk tolerance. Sometimes, even without your taking any action, your portfolio might change in ways you hadn't expected. For example, suppose you wanted your portfolio to contain 60% stocks and 40% bonds and other investments. After a period of rising prices, though, the value of your stocks may have increased so much that they now occupy 65% of your portfolio - which means you may be taking on more risk than you had originally intended. Consequently, you may need to rebalance your portfolio to get back to your original 60% to 40% ratios. (Keep in mind that these figures are just for illustration; everyone's ideal portfolio mix will depend on their individ-

These aren't the only year-end moves you may want to consider, but they can help you close out 2018 on a positive note. Plus, they can serve as a reminder that you need to be vigilant as you keep working toward your financial goals.

It's even harder to recruit men and women of color; Jensen said if we want future minority educators, it's important that school children grow up seeing educators of all ethnicities. Educators Rising reports that more than half of the American public school student population are students of color, yet more than 80 percent of teachers are white. Jensen said the program could make a major impact in inner cities.

She said there are a lot of misconceptions that are leading to the teacher shortage. Many parents would rather see their children go into technology fields or those that have traditionally come with higher salaries, such as medicine or law. Jensen said there are misconceptions that teachers aren't paid very well, benefits are bad and it's not worth the work it takes.

But education is where all careers begin, she said.

"For me, it's been a very fulfilling career," she said. "I believe that education is empowerment."

Jensen will present Educators Rising to an even larger group of educators on November 16 in Springfield at the Illinois State Board of Education meeting. If the state board were to approve the program, they would start brainstorming ways to roll it out and offer it to districts. Jensen said she would love to play a role at the statewide level.

"Throughout the course of this year, I have witnessed some amazing work being done in other states in an effort to address [the teacher shortage]," Jensen wrote. "I have some big ideas that could have a formidable impact on how we approach teacher recruitment in Illinois, and it is my hope that this meeting will expand our discourse from one of crisis to one of possibilities."

Dwight Woman Stumbles Upon Long Lost Sisters

Alicia Wyrick Daly, of Dwight, got an email two years ago that would change her life.

She was resting on the couch on January 14, 2016, scrolling through her mail when she came across one that said she might be a long lost sister. Thinking it was spam, she deleted it. But something made her go back

It was from Julie Morris, her biological sister now living in Laguna Hills, Calif.

"My jaw literally did hit the floor," said Alicia, who is a caretaker and secretary at United Lutheran Church in Gardner. Little did she know that she would also meet her second biological sister.

Growing up, Alicia's mother, Ellen Palmer Wyrick, told her she had sisters out there, but never thought much of it until she died in 2008. A year later, after Alicia's husband died, she began thinking more and more about family that may be out there.

Her father-in-law, Joel Daly, a longtime news anchor for Channel 7 Chicago, pointed her in some directions, but she came up cold.

"When you're an only child, you wish you had someone to share things with," Alicia said.

We may live in a world where finding just about anyone is at the tip of your fingers, but it seemed an act of God that brought the Wyrick sisters together.

It all began back in 2015, when Julie's adopted mother, Bert Curtin, died. Her brother gave her a folder he came across in their mother's file drawer. Inside was Julie's original adoption decree from 1959. It gave little information, only her gender and surname at birth: Baby girl, Wyrick. The adoption was closed, so that was the only information

Julie sat on the information for a year, then decided to put the information out on the Internet. She came touch with a Chicago police officer and private investigator who knew of another closed adoption with the same surname: Baby girl, Wyrick.

She contacted the Illinois Department of Public Health and sent off for a non-certified birth certificate. She learned her birth mother's name was Ellen Palmer Wyrick. She contacted the police officer, who looked back in the files and found Baby girl, Wyrick was Kate (Wyrick) Peterson, of Palos Park. "This is the person I think is your sister," he told

Julie Googled her name and found a photo of Kate. They looked so much alike. With much hesitation, she emailed Kate. Did Kate know she had another sister? Did she even know she was adopted? Such news could blow someone's world. She pressed send. The first words in the return email were "Yes."

Kate was born in 1961 and adopted by Gerald and Isabelle Murphy as a newborn. Like Alicia, she was raised as an only child.

Through the years, Isabelle would share "tidbits" with Kate about her adoption including the fact that she had siblings. "Truthfully, I never had the desire to look into it," she

But after receiving that email from Julie on New Year's Eve 2015, she sent off for her non-certified birth certificate and sure enough, it said her birth mother was Ellen Palmer

"It was an amazing twist of fate," Kate said.

Kate and Julie met in Los Angeles a few months later, in January 2016. Kate had big news for Julie: She told her she knew of a third birth sister out there, but didn't know her name.

How they found Alicia was quite phenomenal. As they sat in the lobby of the Los Angeles Hotel on January 14, they found Ellen Palmer Wyrick's obituary online from September 2008. It mentioned a daughter Alicia Daly and a granddaughter Madison Daly.

They searched the Internet for information about Alicia to no avail. even checked Facebook. Nothing.

So they tried searching for Madison Daly on Facebook, found one that lived in Dwight. On her friend list was her mom,

They paid \$29.95 for an Internet search that provided Alicia's email and phone number. Julie sent the email to Alicia, and within hours the two were talking on the

A month later, the three were sitting together at the Sheraton O'Hare, the first time in their lives they had

all been together. They sat talking, but Alicia was more transfixed on her sisters' faces, ones that looked so much like her own. "I wasn't really hearing what they were saying," she said. "I've never seen my eyes looking back at me before."

Julie and Kate found out that their birth parents, Ellen Wyrick Palmer and Lee Palmer, were both previously married and had five grown children between them. They were older and didn't want more children, but Ellen got pregnant and put that baby up for adoption. That was Julie, the oldest of the three. Two years later, Ellen unexpectedly got pregnant again, and gave this baby girl up for adoption, too: Kate, the middle

The adoptions may have caused a rift in the family. When Ellen became pregnant for the third time, the couple decided to keep the baby, and named her Alicia. At the time, Ellen was 42 and Lee was 50.

Alicia said Lee traveled a lot for business, but she was very close to her mother Ellen. She told Julie and Kate that Ellen was a loving mother and friend, a hardworking woman who provided for her family, and

believe was destined to be.

was also a successful race car driver, of all things.

Since then, Julie, 59, Kate, 57, and Alicia, 55, have gotten together five times, including Ellen Wyrick Palmer's family reunion, where Julie and Kate met first cousins and other blood relatives.

Julie, who has a 16-yearold adopted daughter, retired as a pharmaceutical sales from Abbott Laboratories. Kate works for Loyola University in an administrative role and has three children. Alicia's daughter Madison is now

They continue to keep in touch by phone, text and Snapchat, making up for lost years that came together in an uncanny way without DNA samples or Internet sites like Ancestry.com. It's a phenomenon all three

"I think we all feel that our meeting was divine intervention," Kate said.

"We have this unbelievable superglue," Julie said. "You can't deny these girls were meant to be together. It just took 50 years for us to find each other."

III. The property taxes extended for debt service and public building commission leases for 2017 were \$0.00.

The Garfield, Greenfield, Goodfarm Multi Assessing District would like to provide an explanation for the tax increase for the District. Due to the lack of an Assessor, the Multi District has paid \$6,865.85 per year since 2015 to the Grundy County Assessor to perform the Assessing duties for the

On 10/25/2017 the District was given a bill for \$15,107.51 from the County Assessor's office. This was for service from 1/1/2017 to 9/30/2017. This was an increase from the previous years of 120%.

At the same time the District received options for 2018. Since the District did not have an Assessor the option was to sign a contract for the County to perform the assessing duties. This would have cost the District an increase of 278%. If the District did not sign the contract, we would be charged an overtime rate, which amounted to a 614% increase.

The District has hired an Assessor with a starting date of 1/1/2019. With the new Assessor the District will have an increase of 66.78%. Through careful thought and investigation we feel that this is the most cost effective option for our District.

Dwight Approves Christmas Parade Route Village Board Meets November 5

Dwight's annual Christmas parade route and associated street closures were approved by the Dwight Village Board of Trustees when it met on November 5.

The Christmas parade will kick off at 6 p.m. on Friday, November 30, with the parade following the same route as last year. Parade entries will line up on North Prairie Avenue from Mazon Avenue to North street beginning at approximately 5:00 p.m. The parade will head south on Prairie to West Main, crossing the railroad tracks at Mazon Avenue, and travel down East Main Street. The parade will end at East Main and Chippewa. Temporary street closures in the area will be in effect as necessary. The Christmas parade is sponsored by the Dwight Economic Alliance.

Following up on a discussion from the October 22 meeting, the board approved replacement of the yield signs on Delaware street, at the Chicago Street intersection, with stop signs. East and west traffic crossing Chicago Street on Delaware will be required to stop.

In his report to the board. Chief of Police Tim Henson reported that background checks are being completed on police officer applicants as the selection process continues. It was also noted that several \$100 counterfeit bills have been found circulating in the county. Henson noted that one person is in custody related to these incidents.

In Public Forum, resident Joe Eggenberger fol-

lowed up with the board regarding complaints he brought forward at the October 8 board session. Street issues in the 200 block of E Seminole Street causing flooding of driveways and yards were again brought to the board's attention by Eggenberger while requesting that street repairs be directed to this area.

Trustee Jerry Curtis brought up new business with concerns regarding the disrepair of the Family Dollar parking lot. Village Administrator Kevin McNamara said Family Dollar has been contacted and he was told they would look into it. Curtis asked that the request be put in writing and efforts be made to push the repairs needed forward. It was also discussed that there are several street lights out in town. It was noted that these are ComEd owned lights and will be part of their LED replacement project. Curtis also mentioned that it was brought to his attention that there is a tree down in Gooseberry Creek along South Street. It was noted that Bradbury has been contacted for removal.

Livingston Voters Approve Home Care

A good turnout of registered voters in Livingston county resulted in approval of two health care questions in the November 6, 2018, general election.

"Shall the Livingston County Board maintain a Public Health budget" was answered "yes" by 9,900 voters, "no" by 1,884.

The question: "Should Livingston County impose a Senior Citizen Social Services tax not to exceed 0.025%" was approved 7,533 "yes" to 4,201 "no".

The county board had previously voted to phase out the county's home healthcare program which supported independent liv-

Unofficial election results showed 56.5% of the Livingston County electorate cast 12,200 ballots.

Governor Bruce Rauner showed some downstate strength by defeating JB Pritzker in the Livingston County balloting, 7,400 to 3,322. Pritzker prevailed statewide, however, by a half-million votes.

Even the always popular Secretary of State Jesse White was upended in Livingston, Jason Helland prevailing with 6,253 votes

to White's 5,559. White won statewide.

Republican Congressional Representative Adam Kinzinger attracted 8,782 votes in the county to Democratic challenger Sara Dady, 3,265. Kinzinger won the District 16 race by some 49,000 votes.

Four Democratic candidates vied for seats on the Livingston County Board, but none prevailed.

In District 1, votes for 4year terms were: Kathy Arbogast (R), 2,504 James Carley (R), 2,322 William Mays R), (1,990) James Blackard (R), 1,912 Daniel Hobart (D), 1,561 Patrick Killian (R), unopposed, was elected to a 2year term, 2,985 votes.

District 2 votes for four year terms were: Robert Weller (R), 2,940 Steven Lovell (R), 2,779 Gerald Earing (R), 2,727 Bill Wilkey (R), 2,479



Fandom Analytics

The general rule of being a person in 2018 is if you get chirped enough about something, you compose a Medium article to articulate it. *record scratch* You're probably wondering how I ended up here.

This idea wasn't some come-to-Jesus moment, but more of something that gradually built over time as I've been chirped via text and Twitter too many times, and decided to do something about it.

It largely stems from my Patriots "fandom", it's often questioned how big of a Patriots fan I am, if I'm a "real fan", but, until now, it's been very hard to quantitatively measure fandom.

I have developed a points system to gauge how big or small a fan is of a particular sports team. There are four categories where points can be accrued, adding them all together gives you your final total, and thus your fandom ranking. I've added letter grades to the points totals.

19+ Points-A Fan-Super fan-Lives, dies, breathes with the team's success and every big loss crushes their soul

15-18 Points-B Fan- Follows more intently during the postseason but is generally aware of what is happening during the regular season

11-14 Points- C Fan-Casual Fan-watches games if they happen to be on TV while they're changing the channel

7-10 Points- D Fan-Their dad is probably a fan of the team and that's the only time they watch

0-5 Points F Fan- Is probably a Lakers, Cowboys, Yankees and Pittsburgh Penguins fan

Category 1: Apparel

For this category it's very straight forward. You are simply awarded 1 point per apparel item you own of said team that was purchased within the last 5 years. This can include, but is not limited to: hats, shirts, pants, socks, underwear, shoes, sweatshirts, and coats.

The only time this could get hairy is if you attend a college, and you have lots of apparel of said college, does that carry over to the team of said college, for the purpose of keeping things uniform, I will allow in this scenario, any college apparel can be counted toward the final total.

Category 2: Viewership and Attendance

I think it was important to create it as viewership and attendance because if you're a fan of an out-of-market team that would make it very difficult to routinely attend games. Attending games can also be a wealth-and-income issue, and I don't believe it's right to judge someone's fandom upon their income, so they're weighted the same here.

The points system here works as such, for every 10% of games that you watch during the season, you are awarded 1point. Per sport that breaks down to:

2 NFL Games—1 Point

8 NBA games-1 Point

8 NHL games— 1 Point 16 MLB games-1 Point

Of the 4 major sports it's probably the easiest to catch an entire NFL season because of the schedule, but for uniformity's sake, I'm awarding 1 point for every 10% of the season you either attend in person or consume on TV.

Category 3: Engagement

It's one thing to sport gear, it's one thing to catch the games when they're on TV, it's another to be actively engaged with what's taking place with your team. For this category, I'm awarding .5 point for any form of engagement. This includes, tweeting, liking, commenting on Facebook, looking up stats, upcoming schedule. Anything where you go out of your way to actively do something is worth .5. I'm only giving this half a point because it can be easy to rack up this point total if done right. This number is to be averaged over a weekly basis during the season. I think it would be tough to base this number with the inclusion of the off-season as there usually isn't as much in which to engage.

NOTE: This category does not include reading long form articles or listening to podcasts about your team.

Category 4: Intake

I intentionally left out podcasts and long form articles because they belong in their own category. If you're taking the time to read, or listen to something that is going to take you 15+ minutes to get through you should be awarded a full point. This, as with the previous category, is to be accrued weekly throughout the regular season to come to your final point total. 1 podcast, and 1 long article would get you to 2 points in this scenario. Fairly straightforward.

Now for application, I'm going to apply it to my most scrutinized team, the New England Patriots, and the team I'm arguably the biggest fan of, the Chicago Cubs and see where the point totals fall.

New England Patriots:

Apparel items: 3

Percentage of season games watched: 90% Engagement: 3- For me this largely comes from RTs on

Twitter and liking pictures on Instagram. Intake: O-I have to be honest, I'm not doing any of this

when it comes to the Patriots. TOTAL: 15-B-Fan.

I think this is pretty spot on, the engagement number might fluctuate week to week depending on how much I reply, like, RT, etc, but as a whole I think I'm a C+/B- fan of the New England Patriots, and this points system I made up reflects that pretty well.

Chicago Cubs:

Apparel items: 5 Percentage of regular season games watched: 85%

Engagement: 3 Intake: 3

Total: 19.5 A-fan.

I thought this number might come in slightly higher but, maybe I'm not as big a fan as I thought! With baseball it's very difficult to catch every single game, I don't have a record of how many games I watched last year, but I would think I took in around 130 games or so.

This system could probably use some slight changes, but think it provides a nice framework of what being a fan is!

The Great American Smokeout is November 15

Smokeout will take place on Thursday, November 15, 2018. The goal of the event is to set aside a day to help smokers quit smoking or using tobacco products for at least one day with the hope that they will quit for good.

The American Cancer Society encourages smokers to guit by providing the smoker with information that will help them gain an understanding of the positive physical changes that will occur for the smoker once they quit. "Within 20 minutes of smoking their last cigarette, an individual will begin to see a series of changes that will continue for years:

• 20 minutes after quitting – your heart rate and blood pressure drops

• 12 hours after quitting – the amount of carbon monoxide in your blood drops to normal

• 2 weeks – 3 months after quitting – circulation improves and lung function increases

The American Cancer Society's Great American • 1 month to 9 months after quitting – your coughing and shortness of breath decrease

> • 1 year after quitting – your risk of heart disease is half that of a smoker's

• 2-5 years after quitting – your stroke risk is reduced to that of a non-smoker's

• 10 years after quitting – your lung cancer death rate is half that of a smoker's. Your risk of cancers of the mouth, throat, esophagus, bladder, kidney and pancreas decreases

• 15 years after quitting – your risk of heart disease is that of a non-smoker's
