Looking Back on a Year's Worth of News

The Dwight area is full of great people. Whether born and raised in Dwight and living elsewhere, or having lived here all their lives, the community is never void of a good story. Whether welcoming a new pastor, recognizing someone who has given back to the community or been honored for their success and achievements, here's a look back at some great, hard-working citizens - both young and old -- who made headlines and helped put Dwight on the map in 2018. Next week, we'll take a look back on the biggest stories that filled *The Paper* in 2018.

THE ART STUDENTS AT DWIGHT TOWNSHIP HIGH SCHOOL

Dwight Township High School art students were represented in our nation's capital this year in spring and then again in winter.

Some readers may recall the Hollywood

movie, "With Six You Get Egg Roll." Well, with 10 Dwight Township High School Students' art projects, you get egg roll – Egg Roll Art that is, for the 2018 White House Easter Egg Roll on the South Lawn.

DTHS was put on the map by Lindsey Jensen, high

school English teacher who was named the 2018 Illinois Teacher of the Year. Due to that honor, she was contacted by the Federal Department of Education to see if Dwight students would be interested in participating by contributing artwork to the White House Easter Egg Roll. Of course she said yes, and immediately contacted DTHS art instructor Patricia Farrell-Levange whose students submitted art.

The Easter Egg Roll took place April 2, with President Donald J. Trump and First Lady Melania hosting the event on the South Lawn and Ellipse. The Easter Egg Roll is a tradition that dates back to the administration of President Rutherford B. Hayes. Each state in the United States was invited to participate and DTHS represented Illinois.

Then came the ornaments. It was the season for Halloween, but the art students were busy decorating for Christmas -- specifically for the National Christmas Tree in Washington, D.C. When President Donald Trump lit up the national tree on Nov. 30, Dwight represented Illinois, one of 56 states, districts and territories to showcase handmade ornaments.

Twenty-seven students sent 24 ornaments to the White House to be on display as part of the annual event. More than 1,500 students participated in this year's project. One of them was senior Amber Gajda, daughter of Lisa and Jason Gajda of Dwight. She painted the White House with two white oaks (the state tree), a field of violets (the state flower), a white-tailed deer (the state animal) and cardinals flying overhead (the state bird). Amber has been in art all four years, so when Farrell-Levange announced Dwight was chosen to create ornaments for the White House, Amber was one of the first to raise her hand.

"This is a huge accomplishment for a [teenager's art] to be at the White House," said Farrell-Levange.

DIANA LOSCHEN

Tri-Point Ag teacher Diana Loschen has had quite a year.

She graduated college in 1985 with an ag teaching degree and was a novelty being only one of three female ag teachers in Illinois. "Now over 50 percent of ag-ed grads are female," she explained.

And in 2018, she celebrated 30 years at Tri-Point

She began her career search for a job after graduating, and in fact competed for the position at Tri-Point with her future husband, Gary Loschen. Gary got the job, but after three years, he gave up his position to take a position at a bank in Cullom, giving Diana a chance to take over.

"When I started it was much heavier in production agriculture," Loschen said. The course offerings included a semester of small engines and a semester of electricity.

Today ag is much broader. And as the high school's FFA advisor, she led the vet-

erinary science team to nationals this year. In the fall, the team placed third at the National FFA Veterinary Science Career Development in Indianapolis. It is the third third-place award in the nationals under Loschen's leadership.

Team members included Amyjo Steichen, Jimmy Haag, Tara Hummel, and Gabrielle Spangler. Hummel was selected as the national winner for the National FFA Proficiency Award in Small Animal Production and Care. Steichen was among top-placing individuals (4th), as was Haag (5th)

The National FFA Veterinary Science CDE is a competitive event that tests students' abilities to apply veterinary science knowledge and skill in practical settings as well as identify breeds, parasites and equipment, perform injections and more.

"Our team really took the bull by the horns," Loschen said.

THE AHMEDI FAMILY

When it comes to nostalgia, the Dwight area has it, as you can get your kicks on Route 66 that runs through our towns. And a famous place to stop is the Old Rt. 66 Family Restaurant of Dwight, which racked up two more honors in 2018.

Old Route 66 Family Restaurant in Dwight genuinely puts the word "family" into its restaurant, and the quality of food and service continues to earn the business awards. It was named among the Top Broasted Chicken in Illinois by best-thingsillinois.com and one of the top 10 cafes in Illinois from illinoisroadtrip.com.

In fact, Old Rt. 66 Family Restaurant scored higher than the famous White Fence Farm in Romeoville.

Year-end: Put This Year's **Investment Performance in Perspective**

How can you assess your investment portfolio's performance in 2018? The year was full of wild swings in the financial markets, so your own results may well have bounced around quite a bit, too. But you can still get a clear picture of how you did if you keep your investments' returns in the proper perspective - by making sure your expectations are relevant, realistic and reviewed.

Let's look at how these terms can apply to a meaningful evaluation of your investment progress:

Relevant - Many investors compare their portfolio returns to a popular market index, such as the S&P 500. But this comparison is not really valid for a variety of reasons. For one thing, indexes are typically not diversified across different types of investments - the S&P 500, for instance, only tracks large U.S. companies. But your portfolio should consist of a broad range of investments: domestic and international stocks, bonds, mutual funds, government securities and so on, appropriate for your goals and risk tolerance. Also, your portfolio's performance will be affected by your contributions and withdrawals, while market index returns are not. So, instead of measuring your results against an index – and possibly worrying about underperformance – you're better off establishing relevant expectations of your investment returns, based on your specific goals. So, for example, if you want to retire at age 62, you'll need to know the rate of return you need to achieve this goal - and then compare that desired return with your actual results.

Realistic - Ideally, of course, you'd like really high returns with really low risk – but that's really not feasible. To get high returns, you'll need to invest aggressively, which means you'll need your portfolio to be heavily weighted in stocks. However, stocks are also riskier than more conservative investments, such as bonds or government securities. So, you'll need to be realistic in what you can anticipate from your portfolio. You can shoot for high returns and accept the higher level of risk, or you can lower your expectations in exchange for greater stability.

Reviewed - The performance of the financial markets - and also your own portfolio - will fluctuate from year to year. Consequently, it's important to review your portfolio's results and the progress you're making toward your goals on a regular basis, possibly with the help of a financial professional. In these reviews, you may conclude that you're doing fine, or you might discover that you need to rebalance your portfolio by realigning your investments with your goals and risk tolerance, or perhaps make other adjustments - such as changing the amount you invest – to get you back on track. In addition, you may even need to re-evaluate these goals in response to changes in your life – a new job, marriage, new child, and so on – as these changes could affect the rate of return you need from your investments.

As you look back on 2018, and look forward to 2019 and beyond, take a holistic approach to how you evaluate your investments' performance. By looking for relevance, being realistic about what you can expect, and reviewing your portfolio in the context of your goals, risk tolerance and changing circumstances, you can gain a thorough understanding of where you are, where you want to go – and how you can help yourself get there.

On December 18, the Dwight Narcotics Unit, along with the Livingston County Pro-Active Unit, conducted a narcotics investigation resulting in the arrest of Jacob J. Mascolo, 27, of Cullom.

Mascolo was charged with two counts of unlawful delivery of cannabis.

Mascolo, who was out on bond for three other charges of unlawful delivery of a controlled substance, was transported to the Livingston County Jail - where he awaits a new bond hearing for the above mentioned charges.

Drug Dealer Arrested in Mazon

Grundy County Sheriff's Office assisted the Will County Cooperative Police Assistance Team (CPAT), the Joliet Metropolitan Area Narcotics Squad (JMANS), and the Mazon Police Department with the execution of a search warrant at 518 Depot Street, Apartment #1, in Mazon.

As a result of the search warrant, Ryan D. Linn, 39 years of age, was arrested and charged with the following criminal offenses:

- Poessession Controlled Substance with Intent to Deliver-Cocaine -Class X Felony
- Possession of a Controlled Substance with Intent to Deliver-Heroin – Class X

On December 19, the cocaine; 22 grams of powder cocaine; 24 Suboxone strips; 26 Fentanyl labeled patches; 148 Hydrocodone stamped pills; prescription Methadone stamped prescription pills; Clonazopam prescription pills; nine Alprazolam stamped prescription pills; 16.2 grams of powder cocaine found in 22 individually packed separate bags; 196 grams of cannabis.

A total of \$1,199.00 USC was seized as a result of the search warrant.

Linn was taken into custody and transported to the Grundy County Jail. Sheriff Briley said an ongoing investigation conducted by Will County CPAT led to the search warrant and that he is very proud of the joint effort conducted by the law enforcement agencies involved.

"This is a good start for the Grundy County Sheriff's Office toward the goals and mission I've discussed in combatting the heroin and drug issues in Grundy Co.," said Sheriff Briley - who heroin; 21 grams of crack took office on December 1.

Livingston Police Seize Hundreds of Pot Plants

Roberts Man Arrested

A 46-year-old Roberts man's Christmas has gone up in smoke following a Livingston County Sheriff's investigation that resulted in the seizure of more than 200 marijuana

John Randa, 46, was arrested on December 20 and charged with felony charges of possession of

more than 200 cannabis plants, and manufacturing/delivering cannabis.

This is an ongoing investigation, with additional charges and arrests possible, according to a press release from the sheriff's office.

Sheriff Tony Childress said the street value of the pot seized was approximately \$230,000 and one of the largest cannabis grow operations his office has been involved in.

On December 20 an ongoing narcotics investigation led the Livingston County Proactive Unit to execute search warrants on two residences, one in Strawn, and the other in Roberts. Once inside the Strawn home, police discovered a very large scale pot growing operation encompassing the entire house.

This led to a second search warrant being executed at the Roberts residence, where additional pot plants were being

In all, police seized a approximately 400 Cannabis plants weighing 22,800 grams, controlled substances, \$10,379 in U.S. currency, drug paraphernalia, firearms, a 2000 Chevrolet Box Truck, a 2013 Cadillac XTS, a 2003 Chrysler 300, and 2000 and 1999 Harley Davidson motorcycles. Childress said in the release that he anticipates additional seizures in this particular case.

Drive Sober this Holiday Season

To help spread the message about the dangers of driving, the impaired Grundy County Sheriff's Office is partnering with the Illinois Department of Transportation, the Illinois State Police and nearly 200 police and sheriff's departments across the state. The goal is simple: Get impaired drunk drivers off the roads and help save lives.

This high-visibility enforcement campaign, Drive Sober or Get Pulled Over, runs through Jan. 2. Law enforcement will show zero tolerance for drunk or drugged driving.

The National Highway Traffic Safety Administration estimates that 10,874 people were killed in the United States in drunk-driving crashes in 2017. That's one person killed every 48 minutes. In Illinois in 2017, alcohol-impaired vehicle crashes claimed 349

Maria Ahmedi and her husband, Naser, are the "mom and pop" of the literal mom and pop operation, employing their son, Luan, and Luan's wife, Malia; in addition to Maria and Naser's daughters Lindita and Brendita. Maria is the "face" of the restaurant, in the front greeting and serving customers. Maria and Naser worked together for Maria's father, known as Grandpa Jimmy, who was the first of the three-generation restaurant family.

The Ahmedi family opened the restaurant in Dwight, near the corner of Old Route 66 and Illinois Route 17 (Mazon Ave.) in Dwight in 2001. And although the family believes this year's honors are well earned, this is not the first award the restaurant has been accorded. In 2016, the Dwight restaurant was named one of the top 10 restaurants along Route 66 from Illinois to California.



BRIAN GALBREATH

Mead, or honey wine, is one of the fastest growing alcoholic beverages. So where do you open a meadery, a rare find compared to craft beer breweries? Dwight, of course.

Brian Galbreath (shown left) below opened Unpossible Mead this summer in Dwight, one of only a few meaderies in Illinois. And ever since, something sweet has been brewing at 111 E. Chippewa.

Mead is an alcoholic beverage fermented with honey, water and yeast. Galbreath, of Coal City, renovated the 2,300-square-foot building, turning a former plumbing and heating space into a hip place to sip a drink that dates back to 7,000 B.C., predating wine and beer.

"Mead is where craft beer was in the '80s and where wine was in the '70s," Galbreath said. In other words, it's creating a buzz.

According to the American Mead Makers Association, mead is the fastest growing alcoholic beverage in the U.S.

Galbreath purchased the building built in

1898 in July 2017 and got to work renovating the space and making mead. He's done much of the work himself, covering the walls with rustic galvanized metal, building Murphy-style tables, hanging industrial lighting and resurfacing a spacious bar counter.

Self-taught Galbreath has seven giant tanks in the mead making room. He brews meads like Basswood Blossom, which is a traditional light mead; a cherry mead aged on oak; and Lemon Drop, for which he zested more than 200 lemons to steep in the mead.

Galbreath is on the cusp of an emerging trend. The closest meadery to Dwight is in Chicago. But modern mead makers are creating loyal drinkers thanks to a diversity of flavors that can't be found among any other alcoholic beverage. Galbreath said mead can be sweet, dry, still or sparkling.

You can add herbs, spices and fruit. And because it contains no wheat, barley or rye, it's naturally gluten free. But what gives mead its unique character and range of flavors is the honey, offering a delicate floral aroma with a sweet, honeyed aftertaste.

TEAM CARBO **CHAMELEON**

Eleven-yearold Cici Groves can rattle off anything you want to know anything about type 1 diabetes. She can

tell you how to read a food label and all about carbs. She can explain everything she carries in her silver backpack including juice, glucose tablets, extra needles and an emergency glucagon shot and why the bag needs to go with her every moment of the day. And, of course, she can tell you how the disease has changed her life.

"The night I was diagnosed I cried so much," she said. "It's a horrible thing to have, but it has its perks," she said, such as being able to eat a granola bar in class to regulate her blood sugar.

But perhaps the biggest perk in 2018 for young diabetics at Dwight Common School was bringing awareness of the disease to the masses. This fall, Team Carbo Chameleon and their families walked a 5k in Diabetes Research Foundation. Walking proudly in neon-col-

ored tie-dye T-shirts, Team Carbo Chameleon raised \$2,521 -- \$1,521 more than their goal

The team, led by Kim Trainor, a paraprofessional aide in special education at Dwight Common School, consisted of 11-year-old Groves, who was diagnosed in November; Tyler Cox, 12, who was diagnosed at age 5; Kamren Olbrot, 5, who was diagnosed a year ago; and Ameryn Wiles, 7, who was diagnosed as a toddler.

Type 1 diabetes is an autoimmune disease in which the pancreas does not produce insulin, one of the main hormones that regulates blood glucose levels. With the help of insulin, your body breaks down carbohy-

> drates into glucose (also called blood sugar), which it uses for energy. Without insulin, the body resorts to breaking down bodily tissue such as muscle and fat stores.

> Type 1 is different from type 2 diabetes, in which genetics and lifestyle contribute. Type 2 diabetics still produce insulin but are unable to use it effectively. There is nothing anyone can do to prevent type 1, but with lifestyle changes, type 2 diabetes can often

> "Ours will never be reversed until a cure is found," said Trainor.

Mautino Update

Liberty Justice Center in Chicago, representing former Dwight resident David Cooke, filed a 32-page brief November 21 in the 4th Judicial District Appellate Court asking that the court review a July 2018 four-to-four party line vote by the Illinois Board of Elections.

That tie vote had nullified Cooke's complaints against the former Frank Mautino Campaign Committee, Cooke alleging the Mautino Committee had misspent campaign funds while Mautino was an Illinois State Representative.

Mautino became Auditor General of Illinois in January of 2016 after serving nearly 25 years as a Representative.

Cooke's complaint was filed in February of 2016 and, according to Cooke and his lawyers, the Board of Elections has yet to rule on the basic merits of their complaint, which alleged Mautino and his committee had violated the Illinois Election code with excessive and unexplained spending (\$225,000) at Happy's Super Service Station in Spring Valley, and at the Spring Valley City Bank (\$150,000.)

The latest appeal by Cooke's lawyers declares that the Board of Elections clearly erred by failing to find that Cooke presented sufficient evidence showing the Mautino Committee had violated the Illinois Election Code with the payments it made to both the gas station and the bank.

Response briefs from Mautino's lawyers are due at the end of December according to Attorney Jeffrey Schwab of the Liberty Justice Center.

ORDINANCE NO. 2018-5

AN ORDINANCE FOR THE LEVYING AND REDDICK COMMUNITY FIRE PROTECTION DISTRICT IN LIVINGSTON, KANKAKEE and **GRUNDY COUNTIES, ILLINOIS** FOR THE YEAR 2018.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE REDDICK COMMUNITY FIRE PROTECTION DISTRICT IN LIVINGSTON, KANKA-KEE and GRUNDY COUNTIES, ILLINOIS:

SECTION 1: That the sum of Ninety One Thousand One Hundred Eighty Four and 00/100 Dollars (\$91,184.00) be and the same is hereby assessed and levied upon and against all real and personal properly subject to taxation within the limits of said REDDICK COMMUNITY FIRE PROTECTION DISTRICT, as that property is assessed and equalized for the current year, in order to meet and defray all necessary expenses and liabilities of the fire protection district as required by statute or voted by the people in accordance with the law, for such purposes as fire protection and ambulance service for the fiscal year beginning May 1, 2018 and ending April 30, 2019.

SECTION 4: If any item, or any portion thereof, of this Ordinance is for any reason held invalid, such decision shall not affect the validity of the remaining portion or such items or the remaining portion of this Ordinance.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage and signing.

SECTION 6: All Ordinances or parts of Ordinances in conflict herewith or any section hereof are hereby repealed. Passed on November 20, 2018.

New Illinois Car Seat Law Beginning January 1

Illinois State Police (ISP) have announced changes to Child Passenger Protection Act.

Effective January 1, 2019, all motorists traveling on Illinois roadways will be required to secure children under the age of two years old in a rear facing child restraint system.

They are hopeful the change in law will reduce infant injuries and fatalities if they are involved in a traffic crash.

HB4377 provides the following:

Provides that when any person is transporting a child in this state who is under the age of two years old in a motor vehicle of the first division or motor vehicle of the second division weighing 9,000 pounds or less, he/she shall be responsible

for properly securing the child in a rear-facing child restraint system, unless the child weighs more than 40 pounds, is taller than 40 inches, or is traveling in vehicles weighing over 9,000 pounds.

· Parent or guardian must provide child restraints.


Children under the age of eight must be secured in an appropriate child restraint system.

· Every person transporting a child under the age of 8 is responsible for properly securing the child in the vehicle.


"We expect to have 40 trucks soon, and when that is done, we want 100," Faletti told The Paper.

Deb and Bryan Baker, of Verona, hosted children from Ukraine two summers ago, and little did they know what an impact that would have on their lives. They felt such love, they adopted the children permanently, a boy and a girl.

They weren't the only ones whose hearts went out to adopt from the Ukraine. Nicole and Jacob Paulsen, also of Verona, adopted a boy last year..

There are 42.4 million people in the Ukraine, a former Soviet Block nation, now independent. But Nicole and Deb told The Paper the nation of Ukraine is suffering from severe economic hardships, and a great deal of alcoholism, accounting for a large number of orphaned children, more than 100,000.

"They don't have a welfare system," said Nicole, ironic since it is a former communist/socialist country. "They are just now starting to look into a foster system," added Deb.

Both families went through the Host Ukraine program to host children over the summer and during winter break. Under the program, unlike the Foster Parent program in the United States where the family receives a stipend to support the costs of hosting a child, the host parents for Ukrainian children have to pay roughly \$3,000 for each child.

LOYOLA JOURNALISM STUDENT NICK **SCHULTZ**

Dwight's Nick Schultz' reporting dream came true this year when Loyola earned an NCAA Final Four

berth. For Nick Schultz, a sophomore at Loyola University in Chicago, March Madness is truly a crazy time for the budding journalist. He himself has been interviewed on television, and has had a

chance to meet with the famous Loyola team supporter, Sister Jean.

He graduated from Dwight Township High School in 2016, the son of Scott and Mary Schultz of Dwight. But Nick's journalism career did not start out with such a huge national audience. She has been taking eighth grade students from DGS to the Challenger

Center at Heartland Community College in Normal for 11 years. The eighth grade class is broken up into three teams, and she makes three "trips" to Mars each school year. Her 33rd mission came at a time when she was nominated as one of 43 teachers around the nation for the June Scobee Rodgers Innovative Educator Award.

Once on the simulator site in Normal, students have to man the control center, build a rover for traveling on Mars in search of water and life forms, and actually go out onto the surface of mars (in a simulation). They also learn to operate a robotic arm and do navigation in "space." Some students have to calculate how to land the spaceship back on earth safely, which is important if they wish to survive to attend high school next year. She said the experience utilizes skills in math, science, technology, and engineering.

June Scobee Rodgers is the Widow of Jim Scobee, Commander of the ill-fated Challenger Space Shuttle Mission that exploded shortly after launch on Jan. 28, 1986. That mission was the first to feature a teacher in space, Christa McAuliffe. A teacher from Florida took the honor but no doubt the school was proud of the nomination.

'MR. BASEBALL'

Dwight's 'Mr. Baseball' Jim Enger had a field named for him in 2018.

He was surprised on April 15, when the Dwight Youth Baseball/Softball league named Field One for him. His wife June secretly contacted his family and friends where he grew up, in Morris, who attended the ceremony.

Enger turned age 72 on April 19 so this was a surprise birthday present for him, he said. "I had no idea" that the honor was coming, Enger told The Paper. "My sisters from Iowa and four classmates from Morris came. I'm hardly ever without words."



Home Health Care Wanted

In November, a citizens advisory referendum was on the ballot supported by 1,100 signatures. The Livingston County Board also placed a binding referendum on the ballot for a .025% tax increase. Both referendums passed.

Prior to the advisory referendum, citizens worked to preserve the Livingston County Health Care program, which provided nursing and housekeeping support for persons with incomes below \$17,500. Last year the Board determined they would "sunset" the program in November of this year, and cut about \$250,000 from the public health budg-

The citizens referendum "advised" the Board that 9,900 voters supported this type of health care program.

The program allowed people to stay in their homes, maintain some independence and be tax-paying participants.

The Board's referendum was more

The citizens' referendum asked that the Board provide an "adequate" budget to maintain the program which did not require extra taxes, just some reapportioning.

Please email, write, call, or just talk to county board members about this issue. Request that they start open discussions for the re-establishment of the Community Health Care program at their January meetings.





Dwight High School District Approves Tax Levy December Board Actions

Dwight Township High School Board of Education members were again at odds when they met on December 12 while working to set the 2018 Tax Levy.

Last month, Superintendent Dr. Richard Jancek presented projections which reflect an expected substan-EAV increase. According to the three county assessors for Livingston, Grundy and LaSalle Counties, which make up the Dwight Township High School District #230, the 2018 EAV is projected to be \$139,458,727 reflecting a 6.72 percent overall projected increase over the 2017 **EAV** actual \$130,680,142.

With the increased EAV and a healthy overall financial standing including a substantial \$3.9 million balance at the end of FY18 in the District's Education Fund and \$6.2 million over all funds, Dr. Jancek recommended a tax rate reduction and, while board members agreed to lowering the rate, how much lower was the question.

Board President Brian Perschnick and BOE member Kevin Berta, who favored a larger tax rate reduction, asked their fellow board members to consider the District's substantial surplus and whether there is a need to keep accumulating additional fund balances.

"When you look at the bigger picture, in our town of Dwight and the three big taxing bodies, we are the only one that doesn't need the tax revenue as bad as the other two," stated Board

President Brian Perschnick. "So, I think we are doing the citizens of this village a great disservice with these fund balances.'

"We are lowering the rate and we are also promising to completely look at every avenue we have and make sure our students get the best that we can give them," said BOE member Jenn Myzia. "So, I don't think that is a disservice."

Other board members also acknowledged the surplus, but were also cautious and favored not being too aggressive with regards to a reduced levy.

After much discussion, the board approved an overall total tax levy rate of 2.7532 with an extension of \$3,839,602. This is a reduction from the 2017 overall total tax levy rate of 2.8082 and a projected extension increase of \$169,738 (4.63) percent).

Board members Jenn Myzia, Tim Henson, Kim Rodosky, Betty Gantzert, and Paul Warner favored the 2.7532 overall rate with Brian Perschnick and Kevin Berta opposed. In other business, Dr.

Jancek gave a status update

on the proposed fieldhouse project. Over the past year, a committee has investigated both an addition to the existing school building and a standalone detached facility to provide additional gym space. In September, three concept variations were presented to the DTHS BOE outlining a building addition to the existing DTHS gymnasium, extending into the west parking lot with preliminary cost estimates ranging from \$8.3 million to

\$10.7 million. Recently,

committee and BOE members toured a newly-completed \$7.8 mil 32,000 square foot standalone recreation center in Joliet. While larger, the Joliet facility is similar in concept to what the Dwight committee has proposed. A preliminary estimate for a Dwight standalone facility is \$6.5 - \$7 million. Funding for the project would come from multiple areas including, primarily, current District #230 Funds and by securing a \$5 million Alternative Revenue bond. However, a question is currently being investigated as to whether a referendum is required to use tax based money for the construction of a detached facility. Dr. Jancek suggested the next step would be to hold a community forum in January or February to provide information and answer questions. Following, the BOE would be asked to make a decision giving direction to hire an architect and move forward with the facility, or giving direction to drop the project idea entirely.

Curricular programs and initiatives for 2019-20 were discussed including STEM Programs, STEAM Labs and AP online courses. STEM is a curriculum based on the idea of educating students in four specific disciplines - science, technology, engineering and mathematics. The "A" in STEAM signifies inclusion of the Arts. There was a consensus by the board to start exploring initiatives for more enrichment courses and to put a line item in the budget for next year with regard to these programs.

Athletic Director Andy Pittenger along with Jill Haacke were in attendance report on activity fundraising and offer a plan on how sport and club fundraisers could be eliminated with increased participation fees and additional financial support from the district. The board consensus favored seeing a formal proposal on this idea which is to be presented at the January meeting for review by the BOE.

The new ISBE definition of an instructional day, with regard to requirements for a minimum number instruction hours or minutes for a day to be considered a day of student attendance and what that might mean for the district, was discussed. It was noted that while no modification to current practice is required by the district, the ISBE changes do create possible flexibility for schools.



Local post offices made more news in July, when Dwight mail carrier Gloria Piccioli earned the grand prize in the 2018 National Postal Worker Day contest, sponsored by My Fed Benefits, a resource center that helps federal employees with benefit and retirement challenges.

Nearly 200 United States Postal Service workers from around the country entered the contest, but Martin Place Hospital in Madison Heights, Mich. Piccioli's story struck a chord with judges. She was delivering one day several years ago when she

heard screams coming from a garage on her route. She had just delivered mail at the neighbors and was walking across the lawn when she heard the cries for help.

Peeking through the window of the garage, she found a heavy-set man who had fallen on top of his wife, crushing her. "Honestly, I was freaking out. I didn't know what to do," Piccioli said. But instinct and swift action helped save

The wife was trying to get her crippled husband out of their SUV and into his wheelchair when he toppled over, pinning her leg to the stairs. She was unable to get up from underneath him. "She was screaming for help," Piccioli recalled. Piccioli called 9-1-1, then rolled the man off his wife, who suffered a broken leg.

"It was very heartfelt," Piccioli said, "getting that feeling of being appreciated."

The Dwight resident has worked for the village post office since 2009. She has a city route, walking 14 miles a day delivering to 792 places. She delivers *The Paper* every Wednesday.

PASTOR JOHN MUELLER

For the past 20 years, Pastor John Mueller has taught religion on more of a Monday through Friday schedule than early Sunday mornings. He spent nearly two decades teaching ethics and world religion to students at Valley Lutheran High School in Saginaw, Mich.

But when Emmanuel Lutheran Church in Dwight called upon him to serve its congregation, there was no other choice but to say yes. "I believe God wanted me here," Mueller said.

He became the church's new pastor this summer, replacing Pastor Daniel Ognoskie, who served from 1999-2016. Pastor Mueller arrived in June. The church is located at 325 E. Mazon Ave.

HELLCAT PILOT ARTHUR LEACH

Arthur Leach, of Odell, remembers flying a Grumman fighter over China during the second World War, dodging tracer bullets, one after another. Suddenly, he felt something warm running down his back, but strangely didn't feel any pain. He reached behind his back and realized it was sweat.

"I thought I had been hit," the 98-year-old veteran said. "There are no

atheists flying airplanes," he said. "I always thought the 'guy upstairs' was sitting in the seat behind me."

That may have been one of the scariest moments during his time on the USS Yorktown as a U.S. Navy fighter pilot. But facing the Axis Powers and taking down enemy in the South Pacific was his job, and he made it out without injury.

Leach, Odell, and formerly

of Dwight, is well-known for such stories at the Livingston County War Museum in Pontiac. But he's now known statewide having been named a recipient of Illinois' Bicentennial HONOR 200, honoring the work of 200 veterans who continue to make extraordinary contributions.

"There are many that could have been chosen from this museum," said David Estes, the education director for the museum and the one who nominated Leach. "I naturally thought of Art ... because of his incredible story flying all over the Pacific, flying all kinds of aircraft. I think he's a national treasure," Estes said.

The Yorktown carried 3,500 men and 150 fighters and torpedo bombers on an 875-foot-long deck. As a pilot, Leach flew many aircraft, including the T-6 Texan and the Brewster Buffalo, but most of his time he flew the Hellcat, the Navy's dominant fighter in the second half of the Pacific War.

His squadron shot down 91 Japanese aircraft. They dropped napalm on Iwo Jima. Out of 105 pilots in his squadron, 31 pilots were lost due to anti-aircraft gunnery or accidents but they never lost a pilot to Japanese aircraft.

Today, he remains active in the Livingston County War Museum, participating in Skype in the Classroom, sharing his story with youngsters all over the world.

Nominees were evaluated based on their achievements,

and on the extent to which their contributions have aided, benefited and provided inspiration to their community at large. A nominee had to be an Illinois resident, honorably discharged and still living. As part of being honored, Leach received two tickets to the state's official 200th birthday celebration at the United Center in Chicago on Dec. 3.

DR. MICHAEL CICHON

After 36 years, Dr. Michael Cichon finally decided to retire from medicine.

His last day of practice at Dwight Healthcare Center of Morris Hospital was Nov. 30, and his patients wished him a happy retirement at a November reception in St. Patrick's Parish Hall, hosted by Morris Hospital, which bought Cichon's practice two years ago.

Cichon didn't necessarily intend to be a doctor. In college he first wanted to become a mechanical engineer but couldn't understand the course, he said with a laugh. But he loved sci-

FORMER DWIGHT MAYOR DARYL HOLT

After 32 years of public service, Daryl Holt decided to hang up his hat in politics.

Holt, now nearing 80 years old, served as Dwight village president for 12 years and became a Livingston County board member in 2006. He officially stepped down in

Holt represented District 2 on the county board. "When I leave it I hope I leave it better than when I got it," Holt told The Paper.

Holt, 78, recognized by the Livingston County Board in November, receiving a plaque as well as a certificate listing the various county committees he's served on over the years.

In 1969, Holt moved to Dwight from Willard, Ohio, where he worked at the RR Donnelley plant. He joined the Donnelley team in Dwight and spent 39 years there, retiring in 2002.

Holt had always been active in the community, but dove into politics in 1982 when he was elected as a Dwight village trustee. He served until 1991, when he decided to run for village president.

He thoroughly enjoyed his time as mayor, but found serving the county equally enjoyable. Holt said he has been involved in many things that have brightened the county's future. He helped bring the Dollar General store to Streator. He worked on a referendum to bring windmills to Fairbury and Forrest, which ultimately never came to fruition, but he was proud to see a windmill farm welcomed in Odell. He was one of the board members who approved a hog farm in Saunemin.

"I've been at it for 32 years," he said. "It's time for somebody else to pick it up and go with it."

FORMER HOCKEY COACH MIKE OUGHTON Mike Oughton is headed to victory once again.

Five decades after seeing his first Chicago Blackhawks game, Oughton, a Dwight Township High School graduate, is among the first to be inducted into the newly formed Illinois State University's Hockey Hall of Fame.

There, he was a leading scorer and MVP before becoming the head coach that led the Redbirds to its first hockey championship ever during the 1978-79 season. He will be inducted Feb. 16 after a hockey game in Bloomington, ironically against the University of Illinois, the longtime rivals and the team they beat in that first championship.

"It was a really gratifying point in time," said Oughton, 64, and now living in Channahon. "It was pretty cool."

The new Hockey Hall of Fame commemorates ISU's 50th year of having a team, said Mike Mullally, director at USA Hockey and the Amateur Hockey Association of Illinois. He nominated Oughton and is a hockey hall of famer himself.

Oughton is among 10 who will be inducted. Their names will be on a permanent banner that will hang in the Grossinger Motors Arena in Bloomington.

As a highschooler at Dwight, he played running and defensive back on the school football team as well as center forward in hockey through Chicago's Saddle and Cycle Club. In 1971, the year before he graduated, DTHS football won the conference championship, but he was always drawn

> Oughton played when he was at Lake Forest College in Chicago. He transferred to Illinois State University as a junior and played from 1975-77, when the program was still relatively in its infancy. The center forward graduated with a degree in economics, topping off the 1976- 77 hockey season with an impressive 29 goals, 29 assists and 58 points. But what would come would leave him an even greater legacy.

> Oughton decided to continue his education at ISU and earn an MBA. The year he graduated, he was given a scholarship as head coach, overseeing a squad of 25 players and two assistant coaches. His second year of coaching saw the championship victory.

> "Hockey is really a physical game," Oughton said. "I was much more sore after a hockey game [than football]. Hockey, you're just in constant motion.'
