Herscher Author Publishes New Book

Herscher author Jim Ridings has published his 25th book of local history, "Kankakee County Stories."

The book tells unique stories of Kankakee County's past, including many first-person stories told for the first time.

Former Kankakee Mayor Russell Johnson tells of his life in public service, including many tales of local corruption never before told. There is the story of the Kankakee Daily Journal reporter who was arrested in the newspaper office in 1971 for refusal to be inducted into the Army. The story of the infamous "His Community" cult is told by someone who spent five years inside it. A career criminal tells how he believes he escaped harsh punishment by selling his soul to the devil.

The book has stories of local politics, a chapter on the weird and the bizarre, and offbeat tales of love and marriage.

There is an inning-by-inning account of an 1870 baseball game between the Chicago White Stockings and the Kankakee team in which Chicago won by a score of 111 to 5.

Water/Sewer Rates to Increase as Part of Dwight's New Budget

With a balanced budget proposed, an ordinance adopting Dwight's Fiscal Year 2019-2020 budget was approved by the Dwight Village Board following a public hearing on March 25. A full board, minus Trustee Jim Mixen, was in attendance.

During the public hearing, Village Administrator Kevin McNamara highlighted various aspects of the proposed budget.

The budget also calls for an increase in liquor licenses of \$100, low speed vehicle license increases of \$15, and a reorganization of building permits fees for commercial buildings based more on a graduated fee.

The \$9.035 million village operating budget, \$3.064 million of which is for the general fund, is the revenue and expense plan providing for the day-to-day operations of village government and provides all departments with guidelines for expenses throughout the fiscal year, beginning April 1, 2019 through March 31, 2020. McNamara pointed out that general fund revenue remains flat with this budget reflecting a 3.7 percent decrease, or \$118,000 less in revenue, over last fiscal year. "While revenues remain stagnant, the village's fiscal solvency is heavily reliant upon external factors we do not control," stated McNamara in his report. McNamara also indicated that no major changes in the revenue stream from the state is anticipated for the coming year.

"To date, we have not seen any proposed cuts in state funding," stated McNamara. "As always, we keep a vigilant eye on the state budget as it relates to human services and our residents of Fox Center."

Currently Fox is budgeted for 106 residents in a facility that once housed and had a budget for 300 people.

The board also discussed a proposed budgeted \$40,000 expenditure to the Dwight Economic Alliance with Trustee Eggenberger questioning the continued support and suggesting lowering the DEA line item in the budget by \$25,000 citing that, when funding support of the DEA began five years ago, it was indicated that the DEA would be self-sustaining in five years. The board unanimously agreed to reduce the DEA contribution to \$15,000 with this contribution earmarked for the July Fourth fireworks display. The remaining \$25,000 was moved to the capital reserve fund.




Jesse White Offers REAL ID Option to Illinoisans

Illinois Secretary of State Jesse White announced that Illinoisans now have the opportunity to apply for a REAL ID card – a new type of Illinois driver's license or ID card that meets federal guidelines allowing the holder to board airplanes for domestic travel or to enter secure federal facilities beginning October 1, 2020.

The federal government requires REAL ID applicants to provide additional documents to obtain the card. Illinois resident are not required to obtain the new card and can rather choose to keep their current standard driver's license or ID and use a valid passport to board domestic flights after Oct. 1, 2020.

There is no immediate need to apply for a REAL ID card because current Illinois driver's licenses or ID cards will be accepted for domestic air travel or to enter secure federal facilities until Oct. 1, 2020. A valid U.S. passport is an acceptable alternative to a REAL ID card.

The application process for a REAL ID card takes longer at the facility than a standard



DL/ID application since more documents are required by the federal government. As a result, the public is asked to be patient while visiting Driver Services facilities.

The U.S. Department of Homeland Security has certified Illinois as fully compliant with the REAL ID Act - a federal mandate by the U.S. Department of Homeland Security that sets standards for state-issued DL/IDs by making identity documents more secure to combat fraud and identity theft.

REAL ID cards meet security requirements set by the federal government and will have a gold star marking in the top

right corner. Newly-issued standard DL/IDs that do not comply with requirements of the federal REAL ID Act will be marked with the phrase "Federal Limits Apply," as called for by the federal law.

Based on federal guidelines, to obtain an Illinois REAL ID card, all applicants - including those who currently hold a standard Illinois DL/ID - must provide:

• One document proving identity (examples: a U.S. birth certificate, a U.S. passport, an employment authorization document, a permanent resident card or a foreign passport with an approved I-94 form).

Important: Name change documents, such as a marriage certificate, will be required if the applicant's current name is different than the name that appears on the document used to prove identity (example: birth certificate).

 One document proving Social Security Number (SSN) (examples: an SSN card, a W-2 or a pay stub with full SSN).

· Two documents proving residency with the applicant's correct name and address (examples: a utility bill, rental agreement, deed/title or bank statement).

· One document proving signature (examples: a credit/debit card, a canceled check or a current Illinois DL/ID).

A full list of approved documents is available at realid.il sos.gov. Residents are encouraged to use the interactive checklist at realid.ilsos.gov/ checklist.html to determine what documents are recommended to take to the facility in order to apply for a REAL ID.

Dwight Board Approves budget

Trustee Randy Irvin questioned the \$2 per resident support of the Greater Livingston County Economic Development Council and the return on that investment. Adam Dontz, GLCEDC Chief Executive Officer was on hand and presented a detailed annual summary of GLCEDC activity as it relates to economic development directly connected to the village, providing a dollar-todollar accounting of the money invested coming back to Dwight. The board approved renewal of the \$2 per capita contribution to the GLCEDC at an annual total of \$8,504.00.

McNamara's report also captured challenges over the past year that are out of the village's control such as Shopko Corp. filing bankruptcy and closing locations including its Dwight store; the closing of Pfaff's Bakery and Pete's Pancake House; local small business owners retiring and looking to sell out; and several local businesses that have faced, or will soon face, reorganization due to buyouts.

Focusing on positives, he reported that tourism continues to be Dwight's biggest form of economic development with 10,000 people signing the guest book last year at the Texaco Station Welcome Center. New to Dwight were Van Vessen's used car dealership and Umpossible Mead. Dwight saw major investments from OSF/St James, Morris Hospital, and Love's Travel Center. The implantation of an aggressive new home building incentive is hoped to stimulate growth and revenue with two new residences built in 2018.

An application to add farmland properties north of Dwight to an expanded Streator Enterprise Zone is progressing as is the development of a Route 17 / Rt. 66 TIF District. The Tax Increment Financing (TIF) fund reflects property tax monies collected since the establishment of the village's first TIF District in 2009. A \$2 million bond was issued in 2016 to rebuild the streets, sidewalks, storm and sanitary systems in the Downtown Business District. Work on West Main is complete and plans to complete the remainder of the downtown rebuild are currently out for bid.

While acknowledging that the upcoming fiscal year will again be challenging, McNamara closed stating the "implementation of this budget will result in the continued delivery of current services to our residents that they have come to expect."

In other business, Mayor Jared Anderson reported that the proposed immigrant detention center may be in jeopardy of moving forward as Illinois House Bill 2040 has been filed to ban for-profit prisons thereby blocking privately run immigration detention centers in the State of Illinois. The bill, initiated by Democratic State Representative Kelly Cassidy, passed the House Labor and Commerce Committee with an 18 - 10 vote and moves now to the House floor before going to the Senate for approval.

"If it passes, everything we have done will be pretty much swept away," stated Anderson regarding the proposed detention center.

An opening day parade request by Dwight Youth Baseball/Softball to kick off the baseball/softball season was approved. This event will take place on April 14 beginning at 1 p.m. Opening day ceremonies will include a short parade featuring the youth baseball and softball players. The parade will begin at Garrett Park heading south on Washington to the Dwight Grade School loop following around to Columbia Street, then north on Columbia to William and back to Garrett Park. A ceremony at the main baseball field will follow with several games to be played that same day.

The board also approved:

• payment of bills totaling \$117,515.19.

• the February Treasurer's report.

• a fund transfer of \$150,000 from the Sewer Fund to the Sewer Reserve Fund for future construction projects.

• a fund transfer of \$64,998 from the General Fund to the Capital Expenditures Fund for the purpose of paying invoices from previous purchases.

a fund transfer of \$60,000 from the Revolving Loan Fund to the General Fund due to excess funds.

Special liquor license and sound amplification requests for this year's Springfest celebration, slated for May 4, were tabled pending clarification of dates / times.

The next meeting of the Dwight Village Board of Trustees will be at 6:30 p.m., Monday, April 8, in the Public Services Complex.



Pros, Cons of Joint Replacement

To people outside the medical field, joint replacement surgery might sound like a solution that's considered only after all other options have been exhausted. But joint replacement surgery has become very common, even though some studies have suggested certain procedures are being performed unnecessarily.

The decision to undergo surgery is always a patient's to make. Weighing some pros and cons can help.

PROS

The Cleveland Clinic notes that many patients who have undergone joint replacement surgeries have experienced dramatic improvement within a relatively short time after undergoing the surgery. Much of that improvement is related to pain, which for many people becomes overwhelming prior to surgery.

placement surgery is the recovery time. For example, the Cleveland Clinic notes that patients who have knee replacement surgery are usually standing and even moving the joint the day after their surgeries. Within six weeks, those same patients are typically walking comfortably with very little support. While each patient is different, any fears that joint replacement surgery will require patients to be immobile for months after surgery are unwarranted.

Joint replacement surgery also can be a long-term solution, whereas the alternatives might not be. The Cleveland Clinic says that roughly 85 percent of knee implants will last 20 years, and that life expectancy figures to grow as technology advances.

CONS

As beneficial as joint re-Another benefit to joint re- placement surgery can be, it's

not without downsides. Cost is one such disadvantage. How much a patient pays for the surgery depends on his or her coverage, but AARP notes that the average knee replacement surgery costs \$31,000. Such costs can be prohibitive for aging men and women who are no longer working.

Another potential disadvantage to going under the knife, especially for those who are borderline candidates for replacement surgeries, is the likelihood that surgery won't have a significant impact on quality of life. A 2017 study published in the journal BMJ found that knee replacement had minimal effects on quality of life, especially for patients whose arthritis was not severe.

When deciding if surgery is their best option, patients should consider the pros and cons of going under the knife before making their final choice.
