Classics, Cruisers Roll In for Buzz the Gut

*14th Annual Dwight Car Show Brings
in Visitors From Near and Far*

Dozens of classic cars and modern marvels will pull into downtown Dwight on June 22 for the 14th annual Buzz the Gut cruise night

Organizer Randy Irvin said the event will take place from 4-9 p.m. In the past they have held it on East Main Street but because of construction they will hold it in the parking lot of Cherry Red Roasters at East Chippewa and South Franklin streets. And it's going to be bigger and better than ever, he believes.

"You know the owners put a lot of love into them and care into them," he said. "All in all it's a great time."

The 13th Annual Let's Buzz the Gut Cruise Night gets its name from the 1950s practice of "buzzing the gut" or cruising downtown to see everyone else doing the same.

The car show, presented by the Dwight Economic Alliance, annually draws about 100 cars with owners competing for prizes. Classics, muscle cars and trucks all pull up for the fun. Last year they had a 9/11 tribute car, a Route 66 cruiser and a Model A Ford.

"A lot of people take pride in their vehicles," Irvin said, and this is a great opportunity to show off their beauties.

There are nine categories, judged by locals who have plenty of experience as hobbyists or mechanics. Winners receive an engraved wooden wine box and bragging rights.

- A specialized category to be determined.

Irvin said many car shows these days are in it to make money. Dwight actually lowered the entry fee from \$10 to \$5 for early registration and \$15 to \$10 for gate admission. They want to bring visitors from outside of town to show what Dwight has to offer. He hopes participants will take advantage of downtown restaurants and stores.

There will be door prizes and everyone gets a dash plaque, which have become collectors items for some drivers.



A Break From Construction

Joliet Diocese Razes Cabery Rectory

The rectory at St. Joseph Church in Cabery has been demolished in what the preservation society's lawyer believes is a move by the Joliet Diocese to "illustrate control" as appeals to keep the 115-year-old church open as a private chapel continue in Rome.

Brody Hale, a lawyer voluntarily guiding the St. Joseph Preservation Society, led by Cheryl Weaver, of Cabery, said the rectory was razed last month despite a benefactor who had agreed to purchase not only the rectory for \$25,000 but also fund any repairs necessary to keep the church open -- even if it's \$306,000, the estimate from the diocese.

"I'm just appalled," Hale said.

That benefactor is Dr. Neil Rangel, a faithful Roman Catholic who practices endocrinology in Dubai.

Although the rectory was never part of the litigation -- it does not fall under canon law -- Hale believes it was torn down as a power move by Bishop Daniel Conlon, who wants to raze the church, too.

The diocese has refused multiple times to comment about the case, citing the "integrity of canonical process."

The process, as it stands now, has gone all the way to the Supreme Tribunal of the Apostolic Signatura, the Vatican's supreme court. In April, the Congregation of the Clergy in Rome upheld Conlon's decree to tear St. Joseph Church down. The society appealed and has hired Andrea Errera, a canon lawyer, to argue the case to the supreme court.

Rangel is funding all attorney costs, which Hale believes could be as much as \$10,000. The appeals process could take months to a year.

Demolishing the church would cost \$110,000, a sum that would come from the diocese or St. Margaret Mary in Herscher, which acquired St. Joseph when the diocese closed it in 2015. The preservation society believes it would be a waste considering Rangel has pledged to fund renovations and upkeep of the church.

Established as a mission in 1867 and a parish in 1892, the St. Joseph Church Preservation Society has fought demolition for three years now.

Suspicious Fire, Death in
Verona Ruled a Homicide

Grundy County Sheriff Ken Briley, in correlation with Grundy Co. Coroner John Callahan, announced that the cause of death of Verona resident Elizabeth Ann Link, 39, of 3200 S. Verona Road, has been deemed a homicide – as the result of an “undetermined inflicted trauma.”
On Tuesday, May 14, at approximately 5:40 a.m., Grundy Co. Sheriff’s Deputies responded to 3200 S. Verona Rd. for a structure/house fire. As fire officials were extinguishing the fire, the body of Elizabeth A. Link, a resident of the home, was discovered inside the residence. An autopsy was completed later that day, along with toxicology tests. At the request of Sheriff Briley, the Will/Grundy Major Crimes

Task Force was activated, along with the Illinois State Fire Marshal and MABIS-IL Division 15 Fire Investigators to investigate the fire and death of Ms. Link.
Sheriff Briley and Coroner Callahan emphasized – this is an active, ongoing investigation with the goal of bringing justice for Elizabeth. Area Suspect Arrested in
Multiple Vehicle Burglaries
in Shady Oaks

On June 5, Grundy County Sheriff’s Deputies responded to several motor vehicle burglaries that occurred in the Shady Oaks Manufactured Homes Community. Sheriff’s Deputies reported multiple burglaries in the following areas: Beach Street, Aspen Street, Main Street, and Doral Street in Minooka.
From the burglaries, numerous items were reported missing, including cash, prescription medications, cigarettes, fishing poles, wallets, debit cards, jumper cables, a car battery, sound equipment including a kicker speaker with speaker box and an amplifier.
Approximately six hours after being burglarized, one of the victims located his missing items for sale on Facebook Marketplace and reported the information to the Sheriff’s Office. Deputy Darren Roach

conducted an investigation, which led Deputies to a residence on Eisenhower Drive in Dwight. With the assistance of the Dwight Police Department, Deputy Roach approached the residence and observed the garage door open. As he approached the garage door, in plain sight, Deputy Roach observed several items matching the description of items reported stolen. A further investigation led to the arrest of Michael Moats of Dwight and Corey Gibbons of Minooka.

Sheriff Ken Briley extended thanks to the DPD for their assistance and commended Deputy Darren Roach for a job well done.

D-Day

Inspired by the stories surrounding this year’s 75th Anniversary of D-Day, June 6, 1944, Jack Fitzpatrick of Dwight brought the well-worn newspaper clipping at right to The Paper containing a June 2, 1945 letter written to Mrs. Evelyn Fitzpatrick, mother of Army Pfc. Harry Fitzpatrick, one of Jack’s older brothers who served in the European theatre of operations.

The letter was written by Pfc. Fitzpatrick’s company commander concerning the company’s relentless attacks against German forces as the company fought its way across France and into Germany.

Pfc. Harry Fitzpatrick was awarded the Bronze Star as well as the National Defense Medal for his part in the many battles.

Jack Fitzpatrick’s oldest brother, Jimmy, also served in Germany during WWII.

Writes About Her
Son In German

June 2, 1945
Dear Mrs. Fitzpatrick:
I am quite sure you have never heard of me, yet, I, the cause for which we have fought, and our goal, shall live on and you, a daughter, shall never die, the time shall come when you will accept his sacrifice.

That is my purpose as I write this letter. I wish in some way to show my appreciation for the fine, outstanding job your son has done. His accomplishments are in keeping with the highest traditions of bravery and courage in the U. S. Army. I know whereof I speak, for I am his company commander.

Now that hostilities have ceased in this theatre of operations, we have the opportunity to relax somewhat and reminisce. From our entry into action and our first clash with the enemy, the company’s road has been hard and hard. We have fought in the bitter cold, rain, sleet and snow of a Belgian winter. We have bled and thrown back all that the cream of Germany’s forces could bring against us. We held strong, on the “shoulder of the bulge” until it was our lot to attack and oust the foe from his dearly held positions. All during this phase we had more battle than just the enemy; we had the elements. It was here that our present day army was given the test of Valley Forge and not found wanting.

Again we attack, this time crossing the Erfurt Canal at Elsdorf, Germany. From there we fought our way through every ingenious obstacle the Germans could place before us. The “Race to the Rhine” could not have been accomplished without the effort put forth by every individual man.

The Ludendorff bridge at Remagen, Germany, was the scene of many individual heroisms for we crossed under the most adverse conditions of darkness and enemy fire. It was the effort of each individual, teamed with that of others that held the bridgehead, expanded it, and made possible the offensive that carried us headlong to Giessen, Germany.

We then entered the bitter fighting of the Ruhr pocket. Even as cornered rats fight, so did the Germans. Here again every man played his part in bringing glory and honor to this organization.

The pocket finished, we moved into Bavaria and continued to the Rhine. We had crossed the Danube and had helped bring this conflict to an end. The papers have told you the complete story and your son will furnish you the details. However, neither will mention any individual heroisms. Surely, Harry will not, for modesty is just one of his many attributes. Just let me say: no award can be made for the self-sacrifice, the suffering both mental and physical, the hardships he has sustained in protecting our way of life. His devotion to duty has placed all personal feelings and necessities second to that of serving his country. It was his fate and those of men like him that will be discussed forever when men gather to talk of unsung heroes.

You are proud of him, I know, as you have a right to be. I, his commanding officer, am proud to have had the opportunity to command men such as him. I have thanked God for his life and his confidence in me. I, and other officers, should have failed. I express my gratitude to you for the letter and will accept his sacrifice.

Yost House, Jones House Museums Hosting Music Programs June 15

The Catherine V. Yost and the Jones House Museums in Pontiac are each holding a special program featuring music from early in the 20th century Saturday, June 15, from 2:00-4:00 p.m.

The Yost House, located at 298 W. Water St. in Pontiac, will feature local singer Anne Finnegan, accompanied by a circa 1850 baby grand piano played by Paula Trainor-Rosenbaum. They will perform a variety of early 20th century songs until 3:30 p.m., and an original-to-the-home, hand cranked Victrola will be played featuring a number of early 20th century recordings. Admission is free, as is parking in the public lot at the corner of Mill and Water Streets.

The Jones House, located at 314 E. Madison St. in Pontiac, will feature a recently restored 1851 Melodeon, plus music from a Victrola as well. Additionally, guitar music will be played on the second floor. Admission is free and free on-street parking is available.

The Yost House is an 1898 Queen Anne Victorian home, built and occupied by the Z.F. Yost family – which was a prominent Pontiac family throughout the late 19th and most of the 20th century. Everything in the house is original to the family, which is unique and gives visitors an opportunity to discover how the family lived for nearly 100 years.

The Jones House is Pontiac’s oldest surviving brick dwelling. It has been restored and furnished with a variety of items from throughout the 19th and 20th centuries.



Community Forum Held for DTHS Fieldhouse Project

Community members were invited to an open forum at Dwight Township High School on June 5 to review concept designs, ask questions and provide feedback on a proposed fieldhouse project. An estimated 60 persons attended the meeting.

In November of 2017, the DTHS Board of Education approved an Exploratory Committee which began looking at the feasibility of a community recreation center. The initial committee was comprised of various community members including Superintendent Dr. Richard Jancek, Kim Rodosky, Tim Henson, Chuck Trainor, Ryan Hansen, Justin Eggenberger, Deb Karch and Bill Flott. Initially, the committee worked on putting together its vision and goals which were to include a facility for all community members to help promote lifelong health and wellness while providing more facility space for athletic and non-athletic activities. The committee has met thirteen times since December 2017 and visited three neighboring fieldhouse facilities while gathering information.

Early on, the concept was presented to various Village of Dwight officials to see if there might be interest in a joint venture between the village and the school district. However, Dwight officials did not express an interest in pursuing the project. The committee forged ahead, focused on providing

more space for athletic activities and other events with an expanded and upgraded facility while also creating a community center for health and wellness.

Two design concepts were presented. Concept 1 is a two-court fieldhouse at a preliminary estimated cost of \$8.3 million for an attached facility or \$9.6 million for a free standing facility (21,776 sq feet new construction with 1,566 sq feet of demo). Concept 2 is a two-court fieldhouse with a fitness center and multipurpose room at a cost of \$10.7 million for an attached facility or \$12.3 million for a free standing facility (26,771 sq feet new construction plus 15,626 sq feet of remodel and 1,566 sq feet of demo). Both concept designs include a two lane indoor walking track. The proposed attached concept designs would be built off of the DTHS gymnasium's west end. The stand-alone concept designs would use the current DTHS Ag plot for the facility.

Proponents for the facility point out that the current limited gym space often creates scheduling challenges and sees teams practicing from early morning to 11 p.m. or later. In addition, the current facility is in need of addressing ADA compliance issues with the current weight room on an upper level with only stair access and no ADA complainant restroom facilities at the west end of the building. Current locker room facilities also need to be renovated.

The biggest concern is funding. With Dwight's High School District in a very healthy financial state, including a \$6 million total fund surplus and no other current debt, funding options presented include using a portion of existing fund balances (\$2.5 million) and then using various other funding sources such as Alternative Revenue Bonds paid for with wind turbine and sales tax revenues (\$300,000 annually); construction bonds; and a possible Vertical Construction Grant which, if received, is a 50/50 matching grant. An increased tax rate to reduce the length of the bond payback could be considered. It was noted that the tax rates at both Dwight public schools have gone down each year since 2015. Another concern is the declining enrollment at both Dwight schools. However, Dr. Jancek noted that participation numbers have not declined along with enrollment.

The next step will be to take community feedback from the meeting to the DTHS Board of Education on June 19. The board will decide in the coming months whether it wants to move forward with one of the facility concepts and if that facility would be attached or detached. A detached facility requires the project go to referendum, but the board could choose to take either project to referendum to ensure voters have a voice in the project decision. If the project goes to referendum, that vote would not take place until April 2020.





Dwight Fire Recruits Learn Tools of the Trade

The Dwight Fire Protection District has been busy with its fire academy.

On May 6 the duty crew trained on how to draft water from a static supply. The process of raising water from a static source to supply a pumper is known as drafting. This type of operation may occur from any type of static water source including lakes, ponds, portable tanks, and water-carrying vehicles without pumps.

On May 18, the academy went through practical evolutions for the proper selection, carrying, and deploying of ground ladders. Recruits were tasked with setting up the ladders to access the roof of structures for ventilation, as well as to access windows for rescue and entry into a building, according to Public Information Officer Johna Bradley. Following the ladder practicals, recruits were sent inside the building to perform search practicals under smoke conditions, tasked with clearing rooms, searching and removal of victims, and locating the fire.

Forcible entry is a fundamental skill recruits are learning. A successful forcible entry operation consists of four points:

1. A skilled forcible entry size-up.

2. The department purchasing the most efficient tools for forcible entry tasks.

3. Learning and training on the most efficient way to utilize those tools.

4. Formulating and training on a plan of attack for any forcible entry problem that could be encountered.

Each Basic Operations Firefighter (BOF) Academy receives multiple lectures and a day of hands-on training practicing the points above, Bradley said. Additionally, throughout the year, all firefighters train on the forcible entry props multiple times. Each training evolution replicates a forcible entry scenario to put the firefighter in a realistic fire ground situation.

Some of the scenarios include: Using the leverage of a Halligan tool and axe to break a door to an apartment, house or store; cutting padlocks or other locking devices with a power saw; using a power saw to remove window bars or gates; or simply practicing a ‘non-destructive’ method of entry to use when applicable.

The current administration of the Dwight Fire Protection District has upgraded all forcible entry tools, power saws and training props to a modern, cutting-edge level and the instructing staff of the department is second to none in the region.

Training can be loud and perhaps even a bit disruptive. But Bradley said they are doing it for the taxpayer to make Dwight the most professional fire department in the region.



Community Forum Held for DTHS Fieldhouse Project

Community members were invited to an open forum at Dwight Township High School on June 5 to review concept designs, ask questions and provide feedback on a proposed fieldhouse project. An estimated 60 persons attended the meeting.

In November of 2017, the DTHS Board of Education approved an Exploratory Committee which began looking at the feasibility of a community recreation center. The initial committee was comprised of various community members including Superintendent Dr. Richard Jancek, Kim Rodosky, Tim Henson, Chuck Trainor, Ryan Hansen, Justin Eggenberger, Deb Karch and Bill Flott. Initially, the committee worked on putting together its vision and goals which were to include a facility for all community members to help promote lifelong health and wellness while providing more facility space for athletic and non-athletic activities. The committee has met thirteen times since December 2017 and visited three neighboring fieldhouse facilities while gathering information.

Early on, the concept was presented to various Village of Dwight officials to see if there might be interest in a joint venture between the village and the school district. However, Dwight officials did not express an interest in perusing the project. The committee forged ahead, focused on providing

more space for athletic activities and other events with an expanded and upgraded facility while also creating a community center for health and wellness.

Two design concepts were presented. Concept 1 is a two-court fieldhouse at a preliminary estimated cost of \$8.3 million for an attached facility or \$9.6 million for a free standing facility (21,776 sq feet new construction with 1,566 sq feet of demo). Concept 2 is a two-court fieldhouse with a fitness center and multipurpose room at a cost of \$10.7 million for an attached facility or \$12.3 million for a free standing facility (26,771 sq feet new construction plus 15,626 sq feet of remodel and 1,566 sq feet of demo). Both concept designs include a two lane indoor walking track. The proposed attached concept designs would be built off of the DTHS gymnasium's west end. The stand-alone concept designs would use the current DTHS Ag plot for the facility.

Proponents for the facility point out that the current limited gym space often creates scheduling challenges and sees teams practicing from early morning to 11 p.m. or later. In addition, the current facility is in need of addressing ADA compliance issues with the current weight room on an upper level with only stair access and no ADA complainant restroom facilities at the west end of the building. Current locker room facilities also need to be renovated.
