Dwight Receives IL Strong Communities Grant

January 25 Board of Trustee Meeting Summary

The Dwight Village Board of Trustees met on January 25 via a teleconference session with all members present.

A Resolution accepting a grant from the Illinois Housing Development Authority's Strong Communities Program was approved by the board. The grant, in the amount of \$60,000, is to be used by the Village of Dwight to preserve affordable housing efforts by assisting with the rehabilitation and/or demolition of abandoned properties within the vil-

Following up on old business, the board approved an amended petition for annexation of approximately 365 acres of land situated east of town known as the McPart L.L.C. parcels (Parcel Index Numbers (PIN) 05-03-400-011 and 05-03-400-010. The amended agreement brings all parcels together with current zoning amended to I1 - Industrial.

At the January 11 session, Mayor Jared Anderson explained that, as this property is presented to prospective clients, it is helpful if there are facilitated agreements with the Village of Dwight for water and sewer should the property be developed. According to Adam Dontz, CEO of the Greater Livingston County Economic Development Coun-

cil, proposals have been submitted to the GLCEDC from national brokerage companies and their recommendation is that the annexation and zoning be done before they move forward with a national marketing campaign. The GLCEDC has negotiated a five-year purchase option for the property and has done its due diligence with regard to inspections and property studies at an investment of approximately \$100,000. The board has approved sending the McPart annexation petition to Dwight's Planning Commission for a public hearing.

With 2020 proving to be an exceptionally challenging year for businesses, Deb Karch, with the Dwight Economic Alliance, noted several accomplishments that took place last year. Highlights of these economic enhancement endeavors include the expansion and renovation of Old Route 66 Restaurant; the opening of Tractor Supply Company (TSC), Dwight's first Fortune 400 Company; the donation by Bank of Pontiac-Dwight Bank of its former location on East Main Street, valued at \$122,000, to the DEA as its new office and job incubator location; the expansion of the Dwight Historical Society location in the historic depot building; a \$248,000 grant secured by Dwight Fire Protection District for turnout gear and other safety needs; and negotiating

tax abatement agreements securing the Blue Sky Solar project, the largest solar farm to be built in Illinois.

A VFW Post 2608 Bucket Brigade Poppy Day request was approved. Donations will be collected at the intersections of Rt. 17 and Rt. 47 from 7 a.m. − 3 p.m. on Friday, April 30 and 7 a.m. – Noon on Saturday, May 1. Proceeds from the VFW Buddy Poppy program are used to assist disabled veterans and help to maintain state and national veterans' rehabilitation and service programs.

2020 bills totaling \$68,167.96. • the December 2020 Treasurer's Report.

St. Paul School Receives High Marks for Parent Satisfaction

The Catholic Schools Week celebration, which is taking place this week, through February 6, is looking a little different at St. Paul School, Odell, this year. Traditional events, such as the spelling bee and guest readers, will continue, but they will be held with new safety measures in place in light of the pandemic. Yet, one thing remains consistent at St. Paul School - high parent satisfaction.

This academic year, the Diocese of Peoria conducted a survey on parent satsifaction in a variety of areas. St. Paul School scored high marks and placed well above the average marks for schools within the Diocese.

In fact, all parents responding said they were very satisfied (74%) or satisfied regarding the school providing a safe, structured, and nurturing environment. All parents also expressed satisfaction with the accessibility, approachability, and responsiveness of the administration, office staff, and teachers. Seventy-nine percent



were very satisfied regarding the communication between the school and home, while the majority of the rest of the parents were satisfied.

In response to the query, 'Our family has a sense of belonging at school," 79% marked they were very satisfied while the other 21% selected satisfied. The school scored similar marks when asked if students are treated with care and respect by the principals, teachers, and support staff.

In the surveys, many parents cited the small class sizes, dedicated staff, and family-like atmosphere as strengths of the school. One parent stated, "The school gives our students more of an individualized education.

The school does what is in the best interest of each individual student." Another parent said, "Bullying is not tolerated. Teachers are very helpful to those that do not understand and need that extra help. I like how the children are taught respect, manners, and responsibilities."

Other parents listed the morals taught daily, after school care program, kid-approved hot lunch, affordable tuition, lesson format, and faith as strengths of the school. Parents also were satisfied with the safety measures taken during the pandemic.

St. Paul School currently has limited openings in its classrooms. Typically, during Catholic Schools Week, prospective families are invited to attend an open house to learn more about the school, but since the event cannot be held at this time, any interested parents are encouraged to call 815-998-2194 or e-mail school office@saintpaulodell.com.

New Water Tower for Village of Gardner

The Gardner Village Board met in regular session, January 25, for the first time in 2021.

The board opened by observing a moment of silence in memory of former resident Todd Sandeno, who passed away suddenly.

The board accepted the resignation of Village Attorney Scott Belt. Belt resigned after being appointed Associate Grundy County Circuit Court Judge. Belt had been the Village Attorney since 1989 and recommended Chris Dearth, formerly of Scott Belt and Associates, as his successor. Mayor Serena commented the board will review Dearth's rates and qualifications and act to retain an attorney at a future meeting.

Commissioner Dick Hileman reported the village received a Notice of Violation letter from the Illinois EPA advising them of steps needed to bring the sewer pit into compliance. Village Engineer Casey McCollom stated he believes the proposal from Chamlin & Associates will bring the village into compliance. The corrective actions, outlined in the village response to the IEPA, will include adding rock to and removing sludge from the pits. Hileman also reported repairs were required to the pumps and controls following a power

lican colleagues who spoke out in opposition to a proposal which could increase taxes on small businesses by anywhere from \$500 million to \$1.4 bil-

In the closing hours of the lame duck session, Democrats tried to rush through legislation which would have "decoupled" Illinois from language in the federal CARES Act intended to let hard-hit small businesses deduct their additional pandemic losses from 2020. It would result in the state taking away federal tax relief from small businesses which are barely hanging on due to the pandemic and the shutdowns.

We were able to stop the proposal in its tracks when it was called for a vote in the middle of the night, but the Governor has stated that he intends to make the tax hike a priority for the spring session. This aid from Washington was intended to help businesses survive the many hardships which they have been subjected to over the past year. It should not be swept away by Springfield. I intend to oppose this effort again this spring.

Unemployment went up in **December.** The unemployment rate in Illinois increased to 7.6 percent, up from 6.9 percent in November. The figures reflect the effects of the lockdowns which were reimposed in many parts of the state in the fall. Illinois continues to trail the national average of 6.7 percent. One year ago the unemployment rate in Illinois was 3.5 percent.


Some areas of the economy saw improvement, the largest of which was "Professional and Business Services," where Illinois gained 13,000 jobs. Unfortunately these gains were cancelled out by the loss of 40,900 jobs in "Leisure and Hospitality," the segment of the economy which includes bars and restaurants. Leisure and Hospitality has lost a total of 198,100 jobs over the past year. In total, Illinois lost 423,000

nonfarm jobs in 2020. How much do we owe? As of the time of this writing, the State of Illinois owes \$4,756,288,805 in unpaid bills to state vendors. It does not include debts that can only be estimated.

When interest rates rise, your maturing bonds can be reinvested at these new, higher levels. Be sure you evaluate whether a bond ladder and the securities held within it are consistent with your investment objectives, risk tolerance and financial circumstances.

Furthermore, bonds can provide you with other benefits. For one thing, they can help diversify your portfolio, especially if it's heavily weighted toward stocks. Also, stock and bond prices often (although not always) move in opposite directions, so if the stock market goes through a down period, the value of your bonds may rise. And bonds are usually less volatile than stocks, so they can have a "calming" effect on your portfolio. Plus, if you hold your bonds until maturity, you will get your entire principal back (providing the bond issuer doesn't default, which is generally unlikely if you own investment-grade bonds), so bond ownership gives you a chance to preserve capital while still in-But if the primary reason you have owned bonds is because of the income they offer, you may have to look else-

where during periods of ultra-low interest rates. For example, you could invest in dividend-paying stocks. Some stocks have long track records of increasing dividends, year after year, giving you a potential source of rising income. (Keep in mind, though, that dividends can be increased, decreased or eliminated at any time.) Be aware, though, that stocks are subject to greater risks and market movements than bonds. Ultimately, while bonds may not provide the income they did a few years ago, they can have a place in a long-

term investment strategy. Consider how they might fit into yours.



"The best laid schemes of mice and men gang aft a-gley" -- Robert Burns The quote above might be

applied to the fairy tale known as High Speed Rail that was sold to the nation by the Obama administration in 2009 for \$8-billion. Not every state wanted to partake, but Illinois took its share, added \$300million of its own, and told us high speed trains would soon be whisking us

from Dwight to Chicago or St. Louis in record times.

- In 2012, test runs between Dwight and Pontiac were made at 110 mph, but discontinued.

More speed increases, to 90 or 110 mph, were forecast

However, 79 mph remains the top speed, partly because the Federal Railroad Administration won't allow higher speeds until a Positive Train Control system is installed to keep trains from running into each other.

The High Speed Rail concept was doomed from the start because of rail congestion at Chicago and at St. Louis, but proponents went along with the program in Illinois anyway. New track, new locomotives, new coaches (promised), new \$3.26-million train station in Dwight -but no higher speeds.

And then came the pandemic, which almost halved the number of passengers using Amtrak in 2020

throughout North America.

Result? Amtrak ran out of money. Emergency appropriations (Amtrak wanted \$5-billion) were signed by President Trump which funded Amtrak until the end of the year. Donations were actually sought by the Rail Passenger's Asso-

In correspondence with spokespeople at IDOT last week, I was told "while ridership is down and Illinois is temporarily running half the normal frequencies of our state-supported Amtrak trains because of the pandemic, there has been no thought to making changes in service levels permanent . . .

"Testing on the X-itcs signaling system on the Chicago to St. Louis corridor continues with the expectation that the testing will be completed this year and trains will be able to increase speeds to 90 mph."

The latest ridership figures I could find were for 2019 when Dwight was shown with 10,073 passengers. Actually, ridership was half that number because the 10,073 is for those "arriving and departing" or "boarding and alighting," a double counting procedure which is twice the number of people actually riding the trains. Got it?

A fellow writer called it "a statistical flourish you have to admire."



IHSA Board Announces Sports Schedule for Remainder of 2020-2021

The IHSA Board of Directors met for a special board meeting January 27, where the Board provided an updated sports schedule and other guidance for the remainder of the 2020-2021 school year.

"We understand the high level of anticipation surrounding [today's] announcement, along with the scrutiny that will accompany it," said IHSA Executive Director Craig Anderson. "Ultimately, the Board adhered to its stated goals throughout the pandemic: providing an opportunity for every IHSA studentathlete to compete safely this year and maximixing opportunities for traditional IHSA spring sports after they lost their entire season a year ago. I recognize that many schools and coaches could likely offer a tweak here or there that would have, in their opinion, made it 'better' for their school or sport. Our Board faced an impossible task with a litany of factors. They were conscientious in considering every possibility and I believe their decisions [today] are a positive step for the mental, emotional, and physical well-being of our students. We are excited to channel our energy into creating as many positive experiences for Illinois high school students as we can between now and the end of this extraordinary school

The Board is considering State Series competition for traditional IHSA spring sports only. Dance and cheerleading will be allowed to conduct virtual Sectional and State Final meets, as they will record their performances and submit them to be judged.

"The Board wants to do everything in their power to prevent spring sports from going two consecutive years with no postseason IHSA play," said Anderson. "There are obviously no guarantees, as risk levels by sport and local region mitigation statuses will factor significantly. Postseason could mean being limited to a Regional or Sectional level of competition, but we have not ruled out the idea of playing a full state tournament in these traditional spring sports if possible. The overwhelming feedback we have heard from athletic directors and coaches was that returning to play in all sports should be the main goal."

With the exception of football, which requires individuals to participate in practice on 12 different days, all sports will be required to hold practice on seven different days prior to holding a contest. Holding multiple practices on a date does not impact that timeline. If studentathletes transition from basketball or boys swimming and diving into football, they will need to participate in practice on ten different days prior to their all the mitigations and precaufirst contest. Winter sport contests could begin as early as today, dependent on when a school's Region reached the appropriate mitigation status and when they began practices.

The IHSA Sports Medicine Advisory Committee (SMAC) issued a statement reminding all student-athletes, coaches, and schools on the importance of acclimatization:

"The IHSA SMAC reminds member schools that studentathletes may need additional conditioning in order to participate in a full schedule this seaaddition In season/practice requirements, care needs to be given to each student's individual acclimation as they return to play. When building schedules, attention needs to be given to academic pressure, changes from in-person to remote learning, changes between tiers of mitigation, time spent traveling to events, appropriate time to practice/learn the sport between games, etc. to ensure the student experience truly

enhances the academic day." IHSA guidelines require all student-athletes to participate in masks (with the exception of swimming and diving, gymnasts on an apparatus and outdoor events where social distancing can occur) and for all game personnel not participating in the contest to also wear masks and adhere to social distancing.

"We still have regions of the state that need to make strides in order to be able to play basketball this winter," said Anderson. "That underscores the importance of our schools following

tions. We need to maintain a positive trajectory not only to get winter sports going, but to make sure we do not have any regions regress before spring and summer sports have their opportunity. We can all do our part by wearing a mask and socially distancing."

The Board also agreed to consider other participation opportunities for a given sport, like basketball, if the sport is unable to be played in a specific region.

"We have said from day one that if and when we were allowed to play again this year, the situation would be fluid," said Anderson. "We don't feel great about the notion of some schools falling behind based on their Region's status, but also recognize that we are running out of time and can't afford to hold back the Regions that can play."

In October, the Board ruled that students who play sports (football, boys soccer, girls volleyball) that were displaced from their traditional season could participate on high school and non-school teams simultaneously. The Board affirmed this position in the Jan. 27 meeting with additional sports moving out of their traditional seasons, and also ruled that girls and boys basketball players will need to cease non-school team participation within seven days of their first high school game.

All sports that are out-of-season can conduct contact days through June 4. Contact days are limited to three days per week per sport with a maximum of six hours of contact per week with no interscholastic competition.

The IHSA Board of Directors issued the following statement on the day's events:

"Unprecedented circumstances create extraordinary decisions. The IHSA Board of Directors faced one of the most difficult decisions in the Association's 100-plus year history today. Please know that we did so with great diligence, empathy, and understanding. There were an immense number of factors that went into today's decisions. We knew there would be obstacles no matter what we decided. Whether those hurdles included overlapping seasons for multi-sport athletes, equity between sports, preseason acclimatization guidelines, the prioritization of spring sports, facility conflicts for schools, officiating, and that is just naming a few. Please know that each potential roadblock was recognized and given consideration. The IHSA membership, like our state, is incredibly large and diverse. Each Board member brought different concerns to the table that impacted their own school or region differently. There was never going to be a one-size fits all solution to playing 25 sports seasons in a little over four months. What did occur was collaboration and camaraderie. Each Board member may not have been able to have all of their specific concerns addressed, but we worked together to produce a schedule and plan that we believe will work for our student-athletes."


Lee H. Golding

Livingston County COVID-19 Vaccination Update

The Livingston County Health Department (LCHD) continues to make progress administering the Moderna COVID-19 vaccine to those eligible Livingston County residents. As of January 27, the LCHD has received 2,100 doses of the Moderna vaccine and have administered 1,570 doses to those that qualify, with the remaining doses already scheduled for administration. The LCHD has chosen to prioritize residents age 65 and older, as well as school personnel working in Livingston County schools, within Phase 1B in order to ensure efficient and equitable distribution of the vaccine.

Mass vaccination clinics for Livingston residents age 65 and

older will continue to be held throughout the county in the weeks and months ahead.

As Livingston County continues to work through Phase 1B (Age 65+ and Essential Workers), those residents age 65 and older will receive first priority in vaccination distribution. A questionnaire is available on the LCHD website (https://lchd.us/site/covid-

19-vaccination/) for those age 65 and older to sign up for updates regarding clinic times/dates and appointment availability. Only those Livingston County residents age 65+ may register at this time.

The LCHD recommends reaching out to friends or loved ones age 65 and older in Livingston County

with limited technology or internet access and assisting them in signing up for alerts. If an individual does not have an e-mail address, it is recommended that the person helping him/her sign up enters their own email address to monitor for alerts for their friend or loved one.

Within Phase 1B, the LCHD has also prioritized school personnel working in Livingston County schools. COVID vaccination clinics have been established for all county schools.

The COVID vaccine is not yet available to essential workers in Livingston County as the LCHD is currently focused on vaccinating residents age 65 and older as well as Livingston school personnel. Essential workers eligible within Phase 1B are asked to check the LCHD website regularly for up-to-

date information, as well as The Paper, local media and Facebook (@LivCoHealthIL), as Livingston County progresses through Phase

The COVID vaccine will be administered in Livingston County in accordance with the phases as recommended by the Illinois Department of Public Health (IDPH). Availability and timing of vaccine administration in Livingston County will depend on vaccine delivery from the State of Illinois, as well as uptake of the vaccine by those individuals who are eligible. It is requested that the public refrain from contacting the LCHD with questions regarding the COVID-19 vaccine. If you have questions or concerns about receiving the COVID-19 vaccine, contact

your healthcare provider.
