### LIVINGSTON COUNTY BOARD SHERIFF, JAIL & LICENSE COMMITTEE MINUTES OF AUGUST 4, 2025

Committee Chair Robert Weller called the meeting to order at 5:00 p.m. in the County Board Room of the Historic Courthouse.

Weller called for any additions or corrections to the  $2^{nd}$  revised agenda with none requested. *Motion by Ritter, second by Mays to approve the*  $2^{nd}$  *revised agenda as presented.* **MOTION CARRIED WITH ALL AYES.** 

The Committee reviewed the minutes of the July 7, 2025 meeting. *Motion by Blackard*, second by Ritter to approve the minutes as submitted. **MOTION CARRIED WITH ALL AYES.** 

Mutual Aid Agreement – Illinois Coroners & Medical Examiners Association: The committee reviewed a Mutual Aid Agreement between the Livingston County Coroner's Office and the Illinois Coroners & Medical Examiners Association. Hartley noted that the agreement is being updated solely to reflect Michael Renner as the current Coroner. Motion by Blackard, second by Ritter to recommend approval of the Mutual Aid Agreement between Livingston County and the Illinois Coroners & Medical Examiners Association. MOTION CARRIED WITH ALL AYES.

Turn Key Health Clinics Medical Services Contract: Superintendent Draper reported significant issues with the current medical vendor, citing a complete lack of communication and a failure to meet expectations. As a result, she recommended entering into a contract with a new provider, Turn Key Health Clinics. Draper noted that Turn Key offers lower costs, provides staff training in contingency planning, has an internal agency to assist with nurse shortages, and will offer psychiatry and mental health services. She also reported obtaining reviews from comparable facilities, all of which gave positive feedback about Turn Key's performance. *Motion by Ritter, second by Manker to recommend approval to enter into a contract with Turn Key Health Clinics as the new jail medical services provider.* MOTION CARRIED WITH ALL AYES.

**Monthly Department Report:** Sheriff Bohm reported an increase in speeding violations during the previous month, attributing the rise to the traffic safety campaign, "Speeding Catches Up With You", which was held from July 8 to August 1. The campaign aimed to encourage safer driving habits and raise awareness about the dangers of speeding.

**Housing Report:** Sheriff Bohm reported that there was a recent power outage at the Jail during which the backup generator failed to activate. He commended the Maintenance Department for their prompt and effective response in addressing the issue and restoring operations as quickly as possible.

**Animal Control Report:** A copy of the monthly animal control report was distributed.

**Pro-Active Report:** A copy of the monthly pro-active report was distributed.

Sheriff Bohm shared that local law enforcement agencies have provided positive feedback about the Pro-Active Unit. He noted that the unit has assisted various communities and is receiving recognition for doing a great job.

# ELEVENTH JUDICIAL CIRCUIT COURT (IL) ADMINISTRATIVE ORDER 2025 - 05

### **COURT HOLIDAY SCHEDULE FOR 2026**

#### IT IS ORDERED THAT:

A. The Eleventh Judicial Circuit Court, having adopted the 2026 holiday schedule established by the Illinois Supreme Court, shall adjourn, and the offices of the Circuit Clerk shall not accept filings on the following legal holidays for the year 2026 as amended:

New Year's Day Thursday, January 1 Martin Luther King Day Monday, January 19 Lincoln's Birthday Thursday, February 12 President's Day Monday, February 16 Memorial Day Monday, May 25 Juneteenth Independence Day Friday, June 19 Independence Day (observed) Friday, July 3 Labor Day Monday, September 7 Columbus Day Monday, October 12 Veterans' Day Wednesday, November 11

Thanksgiving Day Thursday, November 26
Thanksgiving Holiday Friday, November 27
Christmas Day Friday, December 25

- B. All matters returnable on said legal holidays shall be continued to the next business day of said court.
- C. The time for filing all motions and pleadings shall be extended to the next business day of said court.
- D. There shall be a court holiday in any county in this Circuit if the court facilities in that county are closed for observance of a holiday not listed above. These additional observances shall be limited to only those situations in which both court security is unavailable and all county government offices are closed.
- E. In the event the court facilities in a county are to remain open on one or more of the holidays above, the Chief Judge may disregard the listed holiday and declare the court open in that jurisdiction on that day.
